The appended Notification will be published in the Tamil Nadu Government Gazette.

5. The Director of Translation, Chennai-600 009, is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Cuddalore District under intimation to the Government.

NOTIFICATION.
