ORDER:

In the Government Order first read above, the Government have approved separate rule namely the New Town Development Plan for Chennai Metropolitan Area (Preparation, Publication and Sanction) Rules, 2022 under sub-section (1) and clauses (i) and (j) of sub section (2) of section 122 read with section 18 of the Tamil Nadu Town and Country Planning Act, 1971, (Tamil Nadu Act 35 of 1972).

- 2. In the letter second read above, the Member Secretary, Chennai Metropolitan Development Authority has stated that, the contiguous site has been identified for Thiruvallur New Town comprising of 11 villages. The site has access from major transport corridors i.e., CPRR and the NH 716A Tirupati Road which ensure better connectivity to the new town as well as to the neighboring towns.
- 3. He has also stated that the Authority in its Resolution No.98/2022, dated 24.11.2022 has resolved to approve the preparation of a detailed economic/business development plan and New Town Development Plan for Thiruvallur by engaging a consultant and also to send the proposal to the Government for notifying the delineated area as the site of the Thiruvallur New Town Development area. The total area of the delineated New Town is 37.74 sq.km comprising of 11 villages.

- 4. The Member Secretary, Chennai Metropolitan Development Authority has therefore requested the Government to notify the 11 Villages included in the delineation of boundary for the proposed New Town under section 10(1)(c) of the Tamil Nadu Town and Country Planning Act, 1971 at Thiruvallur.
- 5. The Government, after careful consideration of the above proposal of the Member Secretary, Chennai Metropolitan Development Authority have decided to declare the intention of the Government, to notify the 11 villages included in the delineation of boundary for the proposed New Town at Thiruvallur appended to this Government Order.
- 6. The appended Notification will be published in the <u>Tamil Nadu</u> <u>Government Gazette</u>.
- 7. The Collector of Thiruvallur District is directed to republish the Notification in the District Gazette.
- 8. The Director of Translation, Chennai 09 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Thiruvallur District under intimation to the Government.
