ORDER:

In the Government Order first read above, the Government have approved separate rule namely the New Town Development Plan for Chennai Metropolitan Area (Preparation, Publication and Sanction) Rules, 2022 under sub-section (1) and clauses (i) and (j) of sub section (2) of section 122 read with section 18 of the Tamil Nadu Town and Country Planning Act, 1971, (Tamil Nadu Act 35 of 1972).

- 2. In the letter second read above, the Member Secretary, Chennai Metropolitan Development Authority has stated that the area for development of the New Town at Minjur has been delineated including the contiguous villages around the Minjur village, bounded by natural boundary of Bay of Bengal on the east, Vallur village on the south and the Kalanji village on the north have been considered as boundary with an extent of 111.62 sq.km. Various factors like the Outer Ring Road, TPP (Thiruvottiyor-Ponneri-Pancheti) Road, Chennai Peripheral Ring Road, Link road to the proposed Chennai Peripheral Ring Road and present Outer Ring Road, Railway connectivity to the nearby growth nodes, existence of residence and major industries, Proximity to the major port like Ennore and Kattupalli are considered to be the important factors for delineation.
- 3. He has also stated that the Authority has resolved to approve the preparation of a detailed economic/business plan and New Town Development Plan for Minjur New Town considering the overall vision to

develop Minjur as an urban growth centre by engaging a consultant and also to send the proposal to the Government for notifying the delineated area as the site of the Minjur New Town Development area. There are 12 villages included in the delineation of boundary for the proposed New Town at Minjur.

- 4. The Member Secretary, Chennai Metropolitan Development Authority has therefore requested the Government to notify the 12 Villages in the delineation of boundary for the proposed New Town under section 10(1)(c) of the Tamil Nadu Town and Country Planning Act, 1971 at Minjur.
- 5. The Government, after careful consideration of the above proposal of the Member Secretary, Chennai Metropolitan Development Authority have decided to declare the intention of the Government, to notify 12 villages included in the delineation of boundary for the proposed New Town at Minjur appended to this Government Order.
- 6. The appended Notification will be published in the <u>Tamil Nadu</u> <u>Government Gazette</u>.
- 7. The Collector of Thiruvallur District is directed to republish the Notification in the <u>District Gazette</u>.
- 8. The Director of Translation Chennai 09 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Thiruvallur District under intimation to the Government.
