APPENDIX. NOTIFICATION.

In exercise of the powers conferred by section 113 read with section 122 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Regularisation of Unapproved Layouts and Plots Rules, 2017, namely:-

AMENDMENT.

In the said Rules to rule 10, the following proviso shall be added, namely:-

"Provided that in cases where all basic infrastructure facilities have been provided up to the satisfaction of the local authority, the development charges collected for such layout may be utilized for providing basic infrastructure facilities such as roads, drinking water and storm water drains in other areas falling with in that particular local authority."
