ORDER:

In the Government Order first read above, Sirkali Local Planning Area was declared under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

- 2. In the Government Order second read above, the Government have issued orders to accord Administrative Sanction for preparation of Master Plan for 75 towns.
- 3. In the letter third read above, the Director of Town and Country Planning has requested the Government to add the additional areas in the said Sirkali Local Planning Area under clause (b) of sub-section (1) of section 10 of the said Act.
- 4. The Government, after careful consideration of the above proposal of the Director of Town and Country Planning, have decided to declare their intention to specify the areas mentioned in the notification appended to the order as Sirkali Local Planning Area under clause (b) of sub-section (1) of section 10 of the said Act.

- 5. The appended notification will be published in the <u>Tamil Nadu</u> <u>Government Gazette.</u>
- 6. The Collector of Mayiladuthurai District is directed to republish the Notification in the District Gazette.
- 7. The Director of Translation, Chennai-9 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Mayiladuthurai District under intimation to the Government.
- 8. The Collector of Mayiladuthurai District is directed to report to Government the date of republication of the notification in the <u>District</u> Gazette.

NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to add the areas of the following revenue villages to the Sirkali Local Planning Area, which has been declared as such <u>vide</u> the Rural Development and Local Administration Department Notification No.II(2)/RUL/2142/74, published at page 218 of Part II–Section 2 of the <u>Tamil Nadu Government Gazette</u>, dated the 17th April 1974, namely:-
