In the Government Order first read above, Vadakku Valliyoor Local Planning Area was declared under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

- 2. In the Government Order second read above, the Government had issued order to accord Administrative Sanction for preparation of Master Plan for 75 towns.
- 3. The Director of Town and Country Planning in his letter third read above has requested the Government to add the additional areas in the said Vadakku Valliyoor Local Planning Area under clause (b) of sub-section (1) of section 10 of the said Act.
- 4. The Government, after careful consideration of the above proposal of the Director of Town and Country Planning have decided to declare their intention to add the additional areas in Vadakku Valliyoor Local Planning Area under clause (b) of sub-section (1) of section 10 of the said Act.

- 5. The appended notification will be published in the <u>Tamil Nadu</u> Government Gazette.
- 6. The Collector of Tirunelveli District is directed to republish the Notification in the District Gazette.
- 7. The Director of Translation, Chennai-9 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Tirunelveli District under intimation to the Government.
- 8. The Collector of Tirunelveli District is directed to report to Government the date of republication of the notification in the <u>District</u> Gazette.
