Rules, 2017 - Notified - Selection Committee Meeting
held – Nomination of experts to the Real Estate Appellate
Tribunal (TNREAT) for the post of Administrative
member - Regarding.

The real estate sector has grown rapidly in the recent years and from the perspective of consumer protection, the Real Estate (Regulation and Development) Act, 2016 has been enacted.

2. Some of the salient features of the Act are as follows:-

- a. Establishment of on Real Estate Regulatory Authority (RERA) in every State in India for monitoring and adjudicating disputes relating to real estate projects (Section 20).
- b. Establishment of fast track dispute resolution mechanism for settlement of real estate disputes through dedicated adjudicating officers and Appellate Tribunal (Section 43 & 44).

3. In pursuance of the said Act, the Government of Tamil Nadu have notified the Tamil Nadu Real Estate (Regulation and Development) Rules, 2017.

4. In the G.O cited, the Government have constituted a Selection Committee for the purpose of Selection of Chairperson and Members of the Real Estate Regulatory Authority and Members of the Real Estate Appellate Tribunal with following members:-

- i. Chief Justice of High Court of Madras or his nominee.
- ii. Secretary, Housing and Urban Development Department.
- iii. Secretary, Law Department.

5. Now Administrative Member post was vacant in Real Estate Appellate Tribunal (REAT) and it is notified in G.O.(Ms)No.65, Housing and Urban Development (UD3(2)) Department, dated 28.06.2023. Hence, the Selection Committee has been constituted on 03.07.2023 and the first Selection Committee Meeting was held on 11.01.2024.

6. The Committee discussed the modalities for selection of the Administrative Member in REAT. The Committee decided to request professional bodies, associations and cadre authorities to nominate / suggest suitable experts in the fields indicated in section 46 of the Real Estate (Regulation and Development) Act, 2016.

7. The qualification prescribed for the post of Administrative Member of the Tribunal is tabulated in the annexure to this letter. The only disqualification prescribed under section 23(2) of the Real Estate (Regulation and Development) Act, 2016, is that the person recommended must not have any financial or other interest as it likely to affect prejudicially his functions as such Member. You may keep note of this aspect in making your suggestion.

8. The candidates suggested should not exceed the age of 62 in order to ensure that they have atleast 3 years tenure.

9. I am therefore to request you to nominate / suggest list of suitable experts in the field of Urban development, Housing Real Estate development, Infrastructure, Economics, Planning, Law, Commerce, Accountancy, Industry, Management, Public affairs or administration and possess experience of atleast twenty years in the field or who has held the post in the Central Government, or a State Government equivalent to the post of Additional Secretary to the Government of India or an equivalent post in the Central Government or an equivalent post in the State Government.

10. The last date for receiving nomination is 12.02.2024. (postal delay will not be considered)

11. I am therefore to request you to nominate/ suggest suitable candidates along with their bio-data to the Secretary to Government, Housing and Urban Development Department, Secretariat, Chennai-9 on or before 12.02.2024 in order to place the same before the Selection Committee for further action.
