NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to add the areas of the following revenue villages to the Dharapuram Local Planning Area, which has been declared as such vide Rural Development and Local Administration Department Notification No.II(2)/RUL/1998/74, published at page 205 of Part II-Section 2 of the Tamil Nadu Government Gazette, dated the 10th April 1974, namely:-
