- 4. The Government, after careful consideration of the above proposal of the Director of Town and Country Planning have decided to declare their intention to include the additional areas in Dharapuram Local Planning Area under clause (b) of sub-section (1) of section 10 of the said Act.

- 5. The appended notification will be published in the <u>Tamil Nadu</u> <u>Government Gazette.</u>
- 6. The Collector of Tiruppur District is directed to republish the Notification in the <u>District Gazette</u>.
- 7. The Director of Translation, Chennai-9 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Tiruppur District under intimation to the Government.
- 8. The Collector of Tiruppur District is directed to report to Government the date of republication of the notification in the <u>District</u> Gazette.

#### NOTIFICATION.
