- 6. The Collector of Tenkasi District is directed to republish the Notification in the District Gazette.
- 7. The Director of Translation, Chennai-9 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Tenkasi District under intimation to the Government.
- 8. The Collector of Tenkasi District is directed to report to the Government the date of republication of the notification in the <u>District</u> Gazette.
