NOTIFICATION

In exercise of the powers conferred by sub-section (4) of section 32 and section 122 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), and sub-section (1) of section 198 of the Tamil Nadu Urban Local Bodies Act, 1998 (Tamil Nadu Act 9 of 1999), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Combined Development and Building Rules, 2019:-

AMENDMENT

In the said Rules, in rule 39,-

- (1) for sub-rule (25), the following sub-rule shall be substituted, namely:-
- "(25) In case of High Rise Buildings in Chennai Metropolitan Area the plan shall be scrutinized and forwarded to Government, with recommendation of a panel comprising of the following members for approval.
