ORDER:

In the letter read above, the Joint Managing Director, Tamil Nadu Slum Clearance Board has stated that the Tamil Nadu Slum Clearance Board has applied for financing from the World Bank towards the cost of the Tamil Nadu Housing and Habitat Development Project. The Third Preparation Mission of World Bank visited Chennai from 9th - 20th September 2019. During the Mission, the World Bank Team decided to change the method of financing for the project from Investment Project Financing to Development Policy Financing. Development Policy Loan provides rapidly-disbursing budget support to Borrower against "Prior Actions" and "Triggers" comprised of policy reform and/or institutional actions as per the agreement with the Bank.

2. Formulation and approval of State Urban Housing and Habitat Development Policy is one of the prior actions to be achieved by the Housing and Urban Development Department of Government of Tamil Nadu, under the Tamil Nadu Housing and Habitat Development Project. He has stated that the World Bank team will engage a consultant to support the finalization of Tamil Nadu Urban Housing and Habitat Development Policy.

3. In this connection, the Joint Managing Director, Tamil Nadu Slum Clearance Board has proposed the Government to form a Housing Policy Committee to periodically discuss the draft Tamil Nadu Urban Housing and Habitat Policy with the Consultant engaged by the World Bank team to
