#### **AMENDMENT**

In the said Rules, in rule 6, for "THE TABLE" the following Table shall be substituted, namely:-

Category and Name of the Post.

Category 1 Chief Community
Development Officer

Must possess a Masters' Degree in Social Work of a recognised University with experience in Urban Community Organisation or Development for a period of not less than ten years.

Category 2 -Community

Must possess a Masters' Degree in Social Work of q recognised University and experience as Community Development Officer Officer in the Tamil Nadu Slum Clearance Board or in the field of Social Service in any department of Government or in a registered Non-Governmental Organisation for a period of not less than five years.

Category 3 -**Community Officer**  Must possess a Master's Degree in Social Work of a recognised University with experience in the field of Social Welfare in any department of Government or in a registered Non-Governmental Organisation for a period of not less than two years".
