ORDER:

In the Government order second read above, orders have been issued according Administrative Sanction for carrying out land acquisition, shifting of service utilities and Investigation works for the “Construction of Road Over Bridge in lieu of Level Crossing No.34 at km 2/4 of Tiruvarur-Mannargudi-Muthupettai road in between Railway km 50/800-50/900 between Kuzhikarai-Tiruvarur Railway Stations in Thanjavur-Nagore-Karaikal section” for an amount of Rs.2080.18 Lakh.

2. In the Government order third read above, orders have been issued according Administrative Sanction for the work of “Construction of Road Over Bridge in lieu of Level Crossing No.34 at km 2/4 of Tiruvarur-Mannargudi-Muthupettai road (State Highways-202) in between Railway km 50/800-50/900 between Kuzhikarai-Tiruvarur Railway stations in Thanjavur-Nagore-Karaikal section” for an amount of Rs.2760.00 Lakh.

3. The Committee on Revised Administrative Sanction constituted in the Government order first read above in its meeting held on 21.12.2021 has approved the following proposal of Chief Engineer (Highways) Projects:

The Chief Engineer (Highways) Projects has therefore requested orders of the Government to accord Revised Administrative Sanction for the work of "Construction of Road Over Bridge in lieu of Level Crossing No.34 at km 2/4 of Tiruvarur-Mannargudi-Muthupettai road (State Highways-202) in between Railway km 50/800-50/900 between Kuzhikarai-Tiruvarur Railway Stations in Thanjavur-Nagore-Karaikal section" for an amount of Rs.45,32,00,000/- (Rs.42,49,36,969/-+Rs.2,82,63,031/-) as recommended by Revised Administrative Sanction Committee including Revision of Schedule of Rates 2022-2023 @ 8% for civil works.

5. The Government after careful examination accept the proposal of Chief Engineer (Highways) Projects as recommended by Revised Administrative Sanction Committee hereby accord Revised Administrative Sanction for an amount of Rs.42,49,36,969/- (Rupees Forty Two Crore Forty Nine Lakh Thirty Six Thousand Nine Hundred and Sixty Nine only) as against the original Administrative Sanction amount of Rs.27,60,00,000/- for the work of "Construction of Road Over Bridge in lieu of Level Crossing No.34 at km 2/4 of Tiruvarur-Mannargudi-Muthupettai road (State Highways-202) in between Railway km 50/800-50/900 between Kuzhikarai-Tiruvarur Railway Stations in Thanjavur-Nagore-Karaikal section" and accord Financial Sanction for a sum of Rs.50,00,000/- (Rupees Fifty Lakh only) in the current financial year 2022-2023. The balance amount will be released in the subsequent financial years based on the requirements.

6. The expenditure sanctioned in para-5 above shall be debited to the following Head of account:

- 5054 Capital Outlay on Roads and Bridges
 - 03 State Highways
 - 101 Bridges
 - State's Expenditure
 - JG Construction of over and under bridges in lieu of existing level crossings.
- 416 Major Works- 01.Major Works
 - IFHRMS DP CODE :5054 03 101 JG 41601)

7. The expenditure sanctioned in para-5 above shall constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund. The Chief Engineer (Highways) Projects, is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. The Chief Engineer (Highways) Projects is also directed to send a draft explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2022-2023 to Finance (B.G-I /PW-I) Department without fail.
