National Highways – Centrally Sponsored Scheme – Revamped Central Road Fund Scheme 2017-18 – Administrative sanction accorded by the Government of India, Ministry of Road Transport and Highways for 102 works – Administrative and Financial sanction of the State Government – Accord – Orders – Issued.

ORDER:-

In the Government Order first read above, administrative sanction have been accorded for a sum of Rs.35591.90 lakhs for 50 works under Revamped Central Road Fund Scheme for the year 2017-18 and the Government has accorded financial sanction for a sum of Rs.10000.00 lakh (Rupees one hundred crore only) for the year 2017-18 and the balance will be released based on the needs.

2. In the Government Letter third read above, in compliance with the Minutes of the Meeting held by Hon'ble Union Minister of Road Transport & Highways & Shipping and Water Resources, River Development and Ganga Rejuvenation and Hon'ble Chief Minister of Tamil

Nadu in Chennai on 23-11-2017, additional proposal have been forwarded under Revamped Central Road Fund Scheme for the year 2017-18 containing 98 Nos. of road works to a length of 706.307 Km amounting to a sum of Rs.680.00 Crore and 16 works under the head of Road Safety at a cost of Rs.70.00 Crore totalling to a sum of Rs.750.00 Crore for obtaining administrative approval from the Ministry of Road Transport and Highways.

- 3. In the Government Letter fourth read above, a list of four works amounting to Rs.70 Crore as Substitution Works in lieu of Road Safety proposals (SI.No.99 to 114) already proposed in Government letter third cited, so as to avail the sanction of the Ministry for Rs.75000.00 lakhs has been forwarded under Revamped Central Road Fund Scheme for the year 2017-18 for obtaining administrative approval from the Ministry of Road Transport & Highways.
- 4. Accordingly, in their letter fifth read above, the Government of India, Ministry of Road Transport and Highways has accorded administrative approval for 102 works amounting to Rs.75000.00 lakhs under the Revamped Central Road Fund Scheme 2017-18 and requested the State Government to accord financial and technical sanction for the individual projects within a period of 4 months from the date of administrative approval, failing which the works shall deemed to have been de-sanctioned as per Central Road Fund Rules, 2007.
- 5. The Government of India have also imposed the following conditions and following of e-procurement:
 - i) Accord technical and financial sanction to the individual projects within a period of four months from the date of administration approval of the works failing which the works will be deemed to have been deleted from the programme.

ii) In any case, the period of completion of project should not exceed 24 months including the period for tendering.

iii) Any excess cost beyond 10% will have to be arranged by Government of Tamil Nadu from their own resources.

iv) No revised estimate will be considered in this scheme.

V) Audit shall admit expenditure on the basis of technically approved and financially sanctioned estimate by the Competent State / Union territory authority.

vi) The release of funds from Ministry of Road Transport & Highways for the Central Road Fund approved works shall be restricted to the State accruals from out of Central Road Fund and the State Government would have to meet the incremental needs of funds for completion of these works.

vii) Further, the State Government shall ensure that completion of the works awarded as Central Road Fund works shall be ensured and payments for such works over and above the central share would have to be assured by the state concerned.

viii) Payment of Bills in excess of possible allocation of funds, as per Central Road Fund Act, 2014. If needed, is to be temporarily arranged by the State Government.

The stipulation made in Ministry's circular letter No.NH-11011/2/2000ix) P&M(Pt), dated 08.08.2007 (Notification No. GSR 475-E, dated 10.07.2007) shall be strictly followed. X)

If the approved road merges with any National Highways, the detail of such junction / location shall be got approved from this Ministry / National Highways

Authority of India before entrusting the work.

The funds used for the project approved as per guidelines circulated to various xi) State Government / UTs as per the Ministry's letter No.RW/NH-11011/2/ 2000-P&M (pt), dated 08.08.2007 (Notification No.GSR 475-E, dated 10.07.2007).

Display boards should be erected on the sanctioned works. xii)

The State / UT has to submit quarterly progress report of all works sanctioned xiii) from the Central Road Fund for the quarter ending June, September, December and March each year in the prescribed proforma as circulated vide Ministry letter No.RW/NH-11011/2/ 2000-P&M (Pt), dated 08.08.2007 (GSR No.475 (E) dated 10.07.2007). The progress report should reach the Ministry not later than one month from the date ending for each quarter.

The Government of Tamil Nadu will be required to furnish work wise utilization xiv) certificate as per Ministry circular No.RW/NH-11011/2/2000-P&M (Pt), dated 08.08.2007 (Notification No. GSR 475-E, dated 10.07.2007) along with quarterly progress report. Further installment of funds will be released to the extent of expenditure incurred as per utilization certificate by 30th April each

year.

The Government of Tamil Nadu should furnish completion certificate duly XV) vetted by Audit after completion of works as stipulated in the sanction.

While according technical and financial sanction, it may be ensured that XVI) the contingencies, works charged establishment and quality control charges

are as per Ministry's guidelines.

The approval is subject to the condition that Government of Tamil Nadu shall xvii) furnish all the relevant details of the roads considered as per Central Road Fund Rules viz. index map showing the area and the proposal, scope / specification of the work in brief, estimated cost of the project based on the actual requirement and proposed starting / completion dated etc., and upgradation of category of roads as per Central Road Fund rules prior to taking up the work.

The expenditure is debitable under Major Head-3601 (Plan) Grants-in-Aid to xviii) State Government; 02-Grants for State Plan Schemes (Sub-Major Head); 02.105-Grants from Central Road Fund (Minor-Head); 01-Grants for State Road; 01.00.35 - Grants for Creation of Capital assets corresponding the Demand No.81 of the Ministry of Road Transport and Highways for the

Financial year 2017-18.

The sanction is subject to obtaining the necessary approval, if needed for carrying out the work from other Department like Railways, Forest etc.,

6. The Chief Engineer (National Highways), Highways Department has stated that it has been ascertained from other wings that out of total number of 102 works proposed under Revamped Central Road Fund (2017-18) Scheme, 101 works have not been taken up in any other schemes. In 1 (one) work proposed at sl.no.99 viz, "Widening from km 21/6-48/2 including strengthening from Km 21/6-25/550, 30/2-31/2, 35/6-39/6 and 44/6, 48/2 including

CD works of Vellemedupettai-Pondy road (via) Mailam" sanctioned with tentative cost of Rs.2000 lakh, the stretch from km 44/8 to km 45/6 (0.8 Km) was taken up under CRIDP during 2016-17. However, during preparation of Estimate based on the surface condition widening & improvement works for the stretch from km 44/8 to km 45/6 (0.8 Km) will be excluded and the corresponding change in nomenclature will be submitted for the approval of the Government.

- 7. The Chief Engineer (National Highways), Highways Department has also stated that the amount sanctioned in the proposed list is only tentative cost. The actual cost will be arrived during the preparation of estimate by considering the surface condition and accordingly technical sanction will be accorded and requested the Government that for the above work, the entire tentative cost of Rs.2000 Lakh may be sanctioned and Financial Sanction for all the works proposed under Revamped Central Road Fund 2017-18 may be accorded.
- 8. The Chief Engineer (National Highways), Highways Department has therefore requested the Government to accord financial sanction for 102 works amounting to Rs.75000.00 lakhs before the prescribed time limit (4 months) as per Central Road Fund Rules, 2007 to avoid de-sanction of the works approved by the Government of India under Revamped Central Road Fund Scheme 2017-18.
- 9. The Government, after careful consideration, accept the proposal of the Chief Engineer (National Highways), Highways Department subject to the facts assured by him on para 6 and 7 above and accord financial sanction for a sum of Rs.750,00,00,000/- (Rupees seven hundred and fifty crore only) for additional 102 (one hundred and two) works (annexed to this order) which are administratively approved by the Government of India, Ministry of Road Transport & Highways under Revamped Central Road Fund Scheme 2017-18 and also impose the conditions in the para 5 above.
- 10. The expenditure sanctioned in Para-10 above shall be debited to the following Head of Account:-

"5054 Capital Outlay on Roads and Bridges – 05.Roads – 800 Other Expenditure – Central Sector Schemes – SA Revamped Central Road Fund – 16 Major works.

- 11. The Chief Engineer (National Highways), Highways Department is directed to accord technical sanction for the works (annexed to this order) within a period of 4 months from the date of administrative approval of the works, failing which the works will be deemed to be deleted from the programme. In any case, the period of completion of the project should not exceed 24 months including periods for tendering. No revised estimates will be considered in this scheme at any cost.
- 12. The Chief Engineer (National Highways), Highways Department is directed to comply with the following conditions:-

- Furnish necessary particulars to Government of India in the prescribed format upon the technical sanction of estimates for all the works sanctioned from Central Road Fund under intimation to the State Government.
- Ensure that the conditions laid down by Government of India, Ministry of ii) Road Transport and Highways as stated at Para-5 above are complied with while implementing the works.
- Ensure that the amount provided for Central Road Fund works are iii) restricted only to the schemes identified and approved by Government of India.
- 13. The Chief Engineer (National Highways), Highways Department is also directed to ensure that the sanctioned works are not included in any other scheme such as Tamil Nadu Road Sector Project, General Maintenance Works, Comprehensive Road Infrastructure Development Programme, Panchayat Union Schemes, Economic Importance Scheme [EIS], Inter State Connectivity Scheme (ISC), NABARD loan works and earlier approved new works, etc.
- 14. The Chief Engineer (National Highways), Highways Department is also directed to furnish the Utilization Certificate along with quarterly progress report from the date of ending of each quarter and get the expenditure reimbursed from Government of India.
- 15. This order issues with the concurrence of Finance Department vide its U.O.No. 29366/PW1/18, dated 21.06.2018.
