ORDER:-

During the Budget Session 2022-2023, Hon'ble Minister for Public Works has announced that preparation of Detailed Project Report will be taken up for “Construction of Foot Over Bridge at Km 217/6 of Nagapattinam- Gudalur - Mysore Road (Abandoned National Highways-67) Karur Town Limit (State Highways Urban 115)”.

2. The Chief Engineer (Highways) Construction and Maintenance in the letter read above has stated that Nagapattinam–Gudalur - Mysore Road (Abandoned National Highways-67) Karur Town Limit (SHU 115) (from km 217-4-219/050) is an important State Highways road. The reach from km 217/4-219/050 runs through thickly populated built-up area near Karur Bus Stand. There is a lot of traffic congestion in this road. As per traffic census 2017, traffic intensity is 31192 PCU. The Right of Way at this location is 33.00m. During peak hours about 1000 people per hour are crossing the road. Hence, construction of Foot Over Bridge is necessary at km 217/6 of Nagapattinam–Gudalur - Mysore Road (Abandoned National Highways-67) Karur Town Limit (State Highways Urban 115).

3. The Chief Engineer (Highways) Construction and Maintenance has therefore requested orders of the Government for preparation of Detailed Project Report at a cost of Rs.10,00,000/- (Rupees Ten Lakh only) for the work of “Construction of Foot Over Bridge at Km 217/6 of Nagapattinam - Gudalur - Mysore Road (Abandoned National Highways-67) Karur Town Limit (SHU 115)”.

4. The Government after careful examination of the proposal of Chief Engineer (Highways) Construction and Maintenance hereby accord Administrative Sanction for Preparation of Detailed Project Report for the work of “Construction of Foot Over Bridge at Km 217/6 of Nagapattinam - Gudalur - Mysore Road (Abandoned National Highways-67) Karur Town Limit (SHU 115)” for a sum of Rs.10,00,000/- (Rupees Ten Lakh only).

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-
