ORDER:

In the Government Order first and second read above orders were issued for formation of separate Tamil Nadu Road Sector Project-II for the implementation of three components viz(i) Network Improvement (ii) Institutional Capacity Enhancement (iii) Road Safety (RS) at the total project cost of Rs.5171 Crore with World Bank Ioan assistance of Rs.1800 Crore (USD 300 Million). Among others for the implementation of field works, field divisions at Salem, Tiruppur, Trichy, Tirunelveli, Tuticorin, Vridhachalam and Kancheepuram have been approved.

- 2. In the Government Orders third read above, orders issued to convert the PPP03 and PPP01 packages in to EPC14, EPC15 and EPC16 and works are progress in the initial stage.
- 3. In the letter fourth read above, the Project Director, Tamil Nadu Road Sector Project-II has stated that Under Network Improvement, road upgradation works have been taken up for a length of 427 Km under Engineering Procurement & Construction (EPC) mode in 10 packages. Out of which, 9 packages of length 391.2 Km, were completed and are under 5 years maintenance and one package of length 35.8 Km is under progress.146.46 Km length of 3 packages have been taken up in PPP mode, out of which PPP02 package of length 70.2 Km has been completed and is under 8 years

maintenance. For executing the above EPC works, 3 Supervision Consulting Services (SC01, SC02 & SC03) were engaged and their services were completed. For executing the PPP02 work, Independent Engineer (IE) has been engaged and their services are nearing completion. Apart from this, two packages of length 581.493 Km was taken up for 5 years maintenance and completed under OPRC mode and handed over to concerned Construction & Maintenance divisions. The remaining 2 packages of PPP have been converted into EPC14, EPC15 & EPC16 and works are under progress in the initial stage.

- 4. The Project Director, Tamil Nadu Road Sector Project-II has further stated that apart from Parent Project, the DEA, Government of India and the World Bank accepted for an Additional Financing to the extent of USD 169.73 Million. During, Virtual Tripartite Portfolio Review meeting held on 22.09.2020 and 07.10.2020, it was decided that due to multiple projects in pipeline for financing, Additional Financing could not be taken up. Further, the World Bank advised to consider utilizing the entire loan amount of Parent Project (USD 300 Million) of Tamil Nadu Road Sector Project-II by retroactive front loading to continue the contracts already awarded and further advised that the state might use its own funds to complete the remaining works. It has been decided to take up the already tendered additional financing Phase I roads EPC11, EPC12 & EPC13.
- 5. The Project Director, Tamil Nadu Road Sector Project-II has also stated that the PPP03 work and PPP01 packages have been converted into EPC 14, EPC15 & EPC16 and works are under progress in the initial stage. Upgradation of three roads EPC11, EPC12& EPC13 have also been taken up and works are under progress in the initial stage. Since all the 6 projects namely, the packages EPC11, EPC12, EPC13, EPC14, EPC15 and EPC16 costs less than 300 Crore and taking into account the MORT&H guidelines/circular, engaging Supervision Consultancy Services may be dispensed and supervising the above works may be entrusted to the Divisional Engineers(H), Tamil Nadu Road Sector Project-II . The Project Director, Tamil Nadu Road Sector Project-II has concluded that as the Construction of 9 EPC packages and PPP02 package works have been completed already, and to execute 6 new packages, the already sanctioned Trichy and Tuticorin divisions may be redeployed to Erode and Tenkasi divisions.
- 6. The Project Director, Tamil Nadu Road Sector Project-II has therefore requested to issue orders for the following :
 - ➤ To engage Divisional Engineers (H), TNRSP II, to supervise the EPC11, EPC12, EPC13, EPC14, EPC15 & EPC16 works without engaging Supervision Consultancy Services SC05, SC06 & SC07.
 - To redeploy the following two divisions with no additional staffing and additional financial implication.

- > The Project Director (H), Tamil Nadu Road Sector Project-II may be authorized to redeploy the subdivisions of the above Divisions based on the need with prior approval form the Government.
- 7. The Government after careful examination accept the proposal of the Project Director, Tamil Nadu Road Sector Project-II and accord approval for the following:
 - To engage Divisional Engineers (H), TNRSP II, to supervise the EPC11, EPC12, EPC13, EPC14, EPC15 & EPC16 works without engaging Supervision Consultancy Services SC05, SC06 & SC07.
 - To redeploy the following two divisions with no additional staffing and additional financial implication.
