## ORDER:

In the Government Order first read above, administrative sanction orders were issued for Rs. 22.15 lakhs for the preparation of Detailed Project Report for the construction of new 4 lane high level bridge near the sunken 2 lane bridge at llayanarkuppam near Kalpakkam at East Coast Road. The consultant engaged for the preparation of Detailed Project Report have submitted DPR along with the cost estimate for a sum of Rs. 24 crore for the above said work.

- 2) The Hon'ble Chief Minister has announced during the Budget demand for the year 2017-2018 as below:-
  - "A new four lane high level bridge at a cost of Rs. 24 crore will be constructed in place of severely damaged bridge at Km 69/300 of Thiruvanmiyur Mamallapuram Marakkanam road at Ilayanarkuppam in Kancheepuram District".
- 3) In the letter 2<sup>rd</sup> read above, the Chairman and Managing Director, Tamil Nadu Road Development Company Limited has requested the Government to accord administrative sanction for a sum of Rs.24 crore for the Construction of new four lane High Level Bridge at Km 69/300 of East Coast Road across sea back water at Ilayanarkuppam near Kalpakkam including the approach realignment and also requested to entrust the above work to TNRDC as Managing Associate for the procurement and implementation of the above work.
- 4) The Government after careful examination accept the proposal of the Chairman and Managing Director, Tamil Nadu Road Development Company Limited and accord administrative sanction for a sum of Rs. 23,77,85,000/- (Rupees Twenty Three Crore Seventy Seven Lakhs and Eighty Five Thousand only) excluding Detailed Project Report cost of Rs.22,15,000/- already sanctioned in the G.O. 1st cited for the Construction of new four lane High Level Bridge near the sunken 2 lane

bridge at Km 69/300 of East Coast Road across sea back water at Ilayanarkuppam near Kalpakkam including the approach realignment and also entrust the above work to Tamil Nadu Road Development Company Limited as Managing Associate for the procurement and implementation of the above work.

5) The Expenditure sanctioned in para 4 above shall be debited to the following head of account:-

"5054 Capital Outlay on Roads and Bridges – 03 State Highways – 101 Bridges - State's Expenditure - JA Original Works - 16 Major Works".

- 6) The expenditure sanctioned in para -4 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2017-18. Pending approval of the Legislature, the expenditure shall initially be met by drawal of an advance from the Contingency Fund. The Chief Engineer (Construction and Maintenance) is directed to calculate the actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this Order. Orders regarding this will be issued by the Finance (BG.I) Department separately. The Chief Engineer (Construction and Maintenance), Highways/Chairman and Managing Director, TNRDC is directed to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates for the year 2017-18 to Finance (PW-I/BG-I) Department at the appropriate time without fail.
- 7) This order issues with the concurrence of Finance Department vide its U.O. No. 1551/PW-I/2018, dated 25.01.2018 with Additional Sanction Ledger No. 2560 (Two thousand five hundred and sixty).
