ORDER:

In G.O 1st read above, administrative sanction was accorded for preparation of DPR for the work of Widening and Improving the road to Multilane branching from Thindal junction at km 7/2 of Erode – Perundurai - Kangeyam road (SH 96) to km 158/4 of Ooty-Kothagiri-Mettupalayam-Sathy-Gobi-Erode road (SH-15) near Kaniravutharkulam via Villarasampatty (km.0/0-8/4).

2. In the Letter 2nd read above, the Chief Engineer (H) Projects has stated that the total length of the road proposed for widening is 8.40 km. The proposed widening of road starts at km 7/2 of Erode-Perundurai-Kangayam road (SH-96) and ends at km 158/4 of Ooty-Kothagiri-Mettupalayam-Sathy-Gobi-Erode road (SH-15) at Kaniravutharkulam. On improving these roads, people of Erode, Perundurai, Kangeyam, Sathy, Gobi, Namakkal, Karur and other habitations nearby will be benefited and has furnished the Detailed Project Report for the above work with an estimate cost of Rs.22.50 Crores including Land acquisition cost for Rs.50,52,000/- by adopting the current Schedule of Rates of the year 2018-19 including GST.

The Chief Engineer (H) Projects has therefore requested the orders of the Government to accord administrative sanction for the work of "Widening and Improving the road to Multilane branching from Thindal junction at km 7/2 of Erode –

Perundurai – Kangeyam road (SH-96) to km 158/4 of Ooty-Kothagiri-Mettupalayam-Sathy-Gobi-Erode road (SH-15) near Kaniravutharkulam via Villarasampatty” including land acquisition for an amount of Rs.22.50 Crores.

3. The Government after careful examination accord administrative sanction for an amount of Rs.20,85,00,000/- (Rupees Twenty crores and eighty five lakhs only) (including Land Acquisition) for the work of “Widening and improving the road to Multilane branching from Thindal junction at km 7/2 of Erode-Perundurai—Kangeyam road (SH-96) to km 158/4 of Ooty-Kothagiri-Mettupalayam-Sathy-Gobi-Erode road (SH-15) near Kaniravutharkulam via Villarasampatty under CRIDP scheme.

4. The expenditure sanctioned at para 3 above shall be met from the existing budget provision under the following head of account :-

“5054 – Capital Outlay On Roads and Bridges – 03 – State Highways – 337 – Road works – State’s Expenditure – JI – Comprehensive Road Infrastructure Development Programme (CRIDP) – State Highways – 416 Major Works”.
