ORDER:-

During the Highways Demand in Assembly session 2021-2022 on 27.08.2021 among others, the Hon'ble Minister, Public works has announced for preparation of Detailed Project Report for certain works.

2. Based on the announcement, in the letter read above, the Chief Engineer (Projects), Highways Department has furnished the proposal along with estimates requesting Administrative Sanction for preparation of Detailed Project Report for the following 7 works at a total cost of Rs.470.60 Lakh as below:-

- 3. The Chief Engineer (Projects), Highways Department has also stated that the above cost includes Planning and Establishment charges payable to Railways for preparation of Design for Railway portion with reference to 2 Road Over Bridges.
- 4. The Chief Engineer (Projects), Highways Department has therefore requested the Government to accord Administrative Sanction for the preparation of Detailed Project Report for the above 7 works at a total cost of Rs.470.60 lakh.
- 5. The Government after careful examination, accept the proposal of the Chief Engineer (Projects), Highways Department and accord administrative sanction for an amount of Rs.4,70,60,000/- for the preparation of Detailed Project Report for the following 7 works (including Planning and Establishment charges payable to Railways for the two Road Over Bridges) and accord financial sanction for a sum of Rs.1,88,24,000/- (Rupees One Crore Eighty Eight Lakh and Twenty Four Thousand Only) in the current financial year 2021-2022. The balance amount will be released in the subsequent financial years based on the need basis.

- 7. The expenditure sanctioned in para-5 above shall constitute an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Construction and Maintenance), Highways Department, Chennai is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. He is also directed to send a draft explanatory notes for including the above expenditure in the Supplementary Estimates 2021-2022 to Finance (BG-I) / (PW-I) Department at the appropriate time without fail.
- 8. The Chief Engineer (Construction and Maintenance), Highways Department is authorized to draw and disburse the amount sanctioned in para 5 above.
