ORDER :-

During the Budget Session 2022-2023, Hon'ble Minister for Public Works has announced that "Preparation of Detailed Project Report will be taken up for Construction of Road Over Bridge at Kutteripattu".

2. The Chief Engineer (Highways) Construction and Maintenance in his letter read above has stated that Vellimedupettai - Pondy road (via) Mailam (SH-136) km.0/0-48/2 is an important SH Road and acts as an Inter State connectivity road of Pondicherry and Andra Pradesh with Tamil Nadu which is under the maintenance of Villupuram (Highways) Construction and Maintenance Division. It is a Double Lane road with a carriageway width of 7.00 m. Vellimedupettai - Pondy Road (Via) Mailam at km 0/0 - 10/2 and 25/0-30/2 has already been taken up for widening from Two lane to Four lane under the Chief Minister Road Development Programme Scheme in the year 2021-22. Further km 13/0 - 21/6 of this road is proposed to be widened from Two lane to Four lane under the Chief Minister Road Development Programme Scheme in the current year. At km 21/2 this road crosses Chennai- Trichy main railway line. The exiting ROB at km 21/2 in Kutteripattu village is having only 2 lane carriageway. Hence, it is very necessary to construct the additional two lane ROB in order to make the road to four lane for free movement of Traffic.

3. The Chief Engineer (Highways) Construction and Maintenance has therefore requested orders of the Government to accord Administrative Sanction for a sum of Rs.36,00,000/- (Rupees Thirty Six Lakh only) for Preparation of Detailed Project Report for the work of "Construction of Additional Two lane Road Over Bridge at km 21/2 (Kutteripattu) of

Vellimedupettai - Pondy road (Via) Mailam at Railway Km 134/28-30 in between Tindivanam - Mailam Railway stations".

4. The Government after careful examination, of the proposal of the Chief Engineer (Highways) Construction and Maintenance hereby accord Administrative Sanction for an amount of Rs.36,00,000/- (Rupees Thirty Six Lakh only) for Preparation of Detailed Project Report for the work of "Construction of Additional Two lane Road Over Bridge at km 21/2 (Kutteripattu) of Vellimedupettai - Pondy road (Via) Mailam at Railway Km 134/28-30 in between Tindivanam - Mailam Railway stations".

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

6. The expenditure sanctioned in Para-4 above is an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Chief Engineer (Highways) Construction and Maintenance is directed to calculate the actual amount required for the period upto next Supplementary Estimate and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. He is also directed to send a draft explanatory note for including the above expenditure in the Supplementary Estimate 2022-2023 to Finance (BG-I/PW-I) Department without fail.

7. This order issues with the concurrence of Finance Department vide its U.O.No.31028/PW-I/2022, dated 27.06.2022 with Administrative Sanction No.0494 (Four Hundred and Ninety Four) (IFHRMS Additional Sanction Ledger No. 2022060494)
