Highways Department – Projects Wing – Vellore Division – Railway Works Programme 2016-17 – Construction of Road Over Bridge at Km 7/2 of Damalerimuthur road in lieu of existing Level Crossing No.92 at Railway Km 220/500-600 in between Somanayakkanpatti and Pachur Railway Stations – Administrative Sanction – Accorded-Orders - Issued.

- 1. G.O. (Ms) No.119, Highways and Minor Ports (HQ2) Department, dated 30.11.2016.
- 2. From the Chief Engineer (Projects), Highways Department, Letter No.4486A/W2/2016/LC 92, dated 04.12.2019 and 29.05.2020.

ORDER:-

In the Government order first read above, among others administrative sanction was accorded for an amount of Rs.22.85 lakhs for the preparation of Detailed Project Report for the above work.

- 2. In the letters second read above, the Chief Engineer (Projects), Highways Department has stated that, the Dhamalerimuthur road (MDR) branches from NH-179A (Salem-Thirupathur-Vaniyambadi road) at Km 108/6 and leads to Natrampalli and joins NH 46 (Krishnagiri-Ranipet road). The vehicular traffic in this road is very heavy. The Train Vehicle Unit at this Level Crossing is 168740 as per October 2012 census. This road links Kudiyankuppam, Dhamalerimuthur, Jolarpet, Thirupathur, Natrampalli, Vaniyambadi, Ambur and Vellore. The Railway gate is closed many times each day for train movements. This causes much inconvenience to road users and also to the local public. Hence, it is very essential to construct Road Over Bridge in lieu of this level crossing to provide uninterrupted train and vehicle movement.
- 3. Based on the detailed quantity estimate and structural drawings the Chief Engineer (Projects), Highways Department has requested the Government to accord administrative sanction for an amount of Rs.20,67,00,000/- for the work of "Construction of Road Over Bridge at Km 7/2 of Damalerimuthur road in lieu of existing Level Crossing No.92 at Railway Km 220/500-600 in between Somanayakkanpatti and Pachur Railway stations".

- 4. The Government after careful examination, accept the proposal of the Chief Engineer (Projects), Highways Department and accord administrative sanction for the work of "Construction of Road Over Bridge at Km 7/2 of Damalerimuthur road in lieu of existing Level Crossing No.92 at Railway Km 220/500-600 in between Somanayakkanpatti and Pachur Railway Stations" at an estimate of Rs.18,30,71,669/-(Rupees Eighteen Crore Thirty Lakhs Seventy One Thousand Six Hundred And Sixty Nine Only), and also accord financial sanction for a sum of Rs.1,00,00,000/- (Rupees One Crore only) for the financial year 2020-2021. The balance amount will be released in the subsequent financial years based on the requirements.
- 5. The expenditure sanctioned in para-4 above shall be debited under the following head of account:-

5054 - Capital Outlay on Roads and Bridges - 80 - General - 800 - Other Expenditure - State's Expenditure - JT - Construction of Railway Over Bridges / Railway Under Bridges - 416 Major Works - 01. Major Works

- 6. The Chief Engineer (Projects), Highways Department is authorized to incur the expenditure sanctioned in para 4 above.
- 7. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund. The Chief Engineer (Projects), Highways Department is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. The Chief Engineer (Projects), Highways Department is also directed to send a draft explanatory notes for inclusion the above expenditure in the Supplementary Estimates 2020-2021 to Finance (B.G-I) Department without fail.
- 8. This order issues with the concurrence of the Finance Department vide its U.O. No.30450/PW-I/2020, dated 21.09.2020 and Additional Sanctioned Ledger No.544 (Five Hundred and Forty Four)
