ORDER

In the circumstances stated by the Chief Engineer (National Highways), Highways Department, Chennai in the reference 2nd read above, the Government accord sanction to engage Thiru.D.Balaraman, Advocate alongwith Thiru.S.Anand Sathiyaseelan as Counsel on record to defend the Government of Tamil Nadu in OMP 289/2015 filed by Government of India, Ministry of Road Transport & Highways before the Hon'ble High Court, Delhi with the fee structure similar to the Arbitration proceedings approved earlier as follows:-

- Air tickets from Chennai - Delhi or actual charges shall be reimbursed.

- Transportation for attending High Court, Delhi (i.e. from residence to Airport, Airport to place of stay, place of stay to High Court and similarly on return) or actual charges.
- Boarding and lodging shall be provided during the hearing at Delhi or actual charges shall be reimbursed.

(ii) **Fee for Thiru.S.Anand Sathiyaseelan (to be engaged as counsel on Record)**

- * Rs.12,000/- per hearing per day
- * Rs.250/- per page subject to minimum of Rs.10,000/- and Maximum of Rs.75,000/- for drafting of document.
