ORDER:

The Hon'ble Chief Minister of Tamil Nadu has announced under Rule 110 in the floor of the Assembly on 12.08.2016 as below.

"நபார்டு வங்கி கடனுதவி பெற்று 80 பாலங்கள் 159 கோடியே 74 லட்சம் ரூபாய் மதிப்பில் கட்டப்படும்."

- 2. In the Government order first read above administrative sanction accorded for the construction / Reconstruction of 24 Bridge works out of 80 works announced above, which are located in State Highways and Major District Roads at a total cost of Rs. 56.7550 crore in which Rs. 45.4040 crore as RIDF-XXII of NABARD loan assistance for the year 2016-17 and Rs.11.3510 crore as State share under 80:20 ratio.
- 3. In the letter second read above the Chief Engineer (NABARD and Rural Roads), Highways Department has now sent the proposal for the Construction/Reconstruction of remaining 56 Bridge works (ie.80-24=56) which are located in Other District Roads / Panchayat Union Roads at a cost of Rs.115.31 crore

which is revised based on the current schedule of rates (i.e. 2016-17). Hence, the excess amount of Rs.12.3205 crore is involved due to change in schedule of Rates in 2016-17.

4. The Abstract of the Bridge works as follows:-

- 5. After detailed examination Government have forwarded the above proposal to NABARD on 20.09.2017.
- 6. In the letter third read above the General Manager, NABARD has now informed that the RIDF Internal Project Sanctioning Committee (ISC) in its meeting held on 27-11-2017 sanctioned among other things, a sum of Rs.9224.40 lakhs under RIDF XXIII loan assistance and 20% (i.e. Rs.2306.10 lakhs) should be met out from the State funds under 80:20 ratio for the construction / reconstructions of 56 Bridge Works.
- 7. The Chief Engineer (NABARD and Rural Roads), Highways Department has, therefore, requested the Government to accord administrative sanction for Construction / Reconstruction of 56 bridge Works at a total cost of Rs.115.31 crore in Other District Roads, and Panchayat Union Roads under NABARD loan assistance (RIDF XXIII) for the year 2017-18.
- 8. The Government, after detailed examination accept the proposal of the Chief Engineer (NABARD and Rural Roads), Highways and accord Administrative Sanction for the Construction / Reconstruction of 56 bridge works in Other District Roads (ODR) / Panchayat Union Roads (PUR) as detailed in the annexure to this order at a total cost of Rs. 115.3050 Crore (Rupees one hundred fifteen crore and thirty lakhs and fifty thousand only) in which Rs. 92.244 crore as RIDF XXIII of NABARD Loan assistance for the year 2017-2018 and Rs.23.061 crore as State Share under 80:20 ratio.
- 9. The expenditure sanctioned in para 7 above shall be debited to the following head of account:

"5054 – Capital Outlay On Roads and Bridges – 04 - District and Other Roads – 337- Road works – State's Expenditure – JZ – Construction/Reconstruction of Bridges with Loan Assistance from NABARD - 16 – Major Works". (DP Code 5054-04-337-JZ-1607).

10. The Chief Engineer (NABARD and Rural Roads), Highways Department, Chennai is authorized to execute the works sanctioned in para 7 above utilizing the

provisions made by NABARD and Government as their shares in full and to incur expenditure under the head of account as specified in para 8 above and complete the works within the time limit prescribed by NABARD. The Chief Engineer (NABARD and Rural Roads), Highways Department is also directed to ensure the quality of works, as per the standards by issuing detailed instructions to the field officers such as Divisional Engineers / Superintending Engineers and to closely monitor and take up action with regard to the quality and timely completion of work as per the standards.
