## **ORDER:**

In the Government order first read above, orders have been issued according Administrative Sanction for the work of "Construction of ROB in lieu of Level Crossing-201 at Km 26/2 of Perambalur – Manamadurai road at Railway Km 270/0 – 100 between Ariyalur and Sillakudi Railway stations" for an amount of Rs.2840.00 Lakh.

2. The Committee on Revised Administrative Sanction constituted in the Government order second read above in its meeting held on 26.11.2021 has approved the following proposal of Chief Engineer (Highways) Projects:

The Chief Engineer (Highways) Projects has therefore requested orders of the Government to accord Revised Administrative Sanction for the work of "Construction of ROB in lieu of Level Crossing-201 at Km 26/2 of Perambalur Manamadurai road at Railway Km 270/0 100 between Ariyalur and Sillakudi Railway stations" for an amount of Rs.39,52,62,123/-(Rupees Thirty Nine Crore Fifty Two Lakh Sixty Two Thousand One Hundred and Twenty Three only) as recommended by Revised Administrative Sanction Committee.
- 4. The Government after careful examination of the proposal of Chief Engineer (Highways) Projects as recommended by Revised Administrative Sanction Committee hereby accord Revised Administrative Sanction for a sum of Rs.39,52,62,123/- for the work of "Construction of Road Over Bridge in lieu of Level Crossing-201 at Km 26/2 of Perambalur Manamadurai road at Railway Km 270/0 100 between Ariyalur and Sillakudi Railway stations", as against the Administrative Sanction amount of Rs.28,40,00,000/- and accord financial sanction for a sum of Rs.11,12,62,123/- (Rupees Eleven Crore, Twelve Lakh, Sixty Two Thousand, One Hundred and Twenty Three only) in the financial year 2022-2023.

5. The expenditure sanctioned in para-4 above shall be debited to the following Head of account:

5054 - Capital Outlay on Roads and Bridges - 80 - General - 800 - Other Expenditure - State's Expenditure - JT - Construction of Railway Over Bridges/Railway Under Bridges - 416 Major Works-01.Major Works" (IFHRMS DPC: 5054-80-800-JT-41601)

- 6. Necessary funds of Rs.11,12,62,123/- will be provided in Revised Estimates/Final Modified Appropriation 2022-2023 to meet the expenditure sanctioned in para 4 above. Pending provision of such funds, the Chief Engineer (Highways) Projects is authorized to incur the expenditure sanctioned above. This expenditure shall be brought to the notice of the Legislative Assembly by specific inclusion in the Supplementary Estimates 2022-2023. The Chief Engineer (Highways) Projects is directed to include the expenditure while sending the Budget proposal for Revised Estimates/Final Modified Appropriation 2022-2023 and also send the draft explanatory notes for inclusion of the expenditure in the Supplementary Estimate 2022-2023 to Government in Finance (BG-I/PW-I) Department, without fall.
