ORDER:-

The Hon'ble Minister of Tamil Nadu has made the following announcement on 27.08.2021 in the floor of the assembly during the budget demand of Highways and Minor Ports Department during the year 2021-2022.

2. Based on the above announcement, the Chief Engineer (H), Construction and Maintenance has sent the proposal for a detailed project report will be prepared for linking Shanmugam Salai with Grand Southern trunk road and Construction of subway at km 26/6 of Grand Southern Trunk for linking East Tambaram with Tambaram Mudichur road and formation of service road.

The details of the above work is summarized below:

- This Road is branching at Km 26/0 of NH – 45 and ending at Km 7/5 of Vandalur – Walajabad which lies in Tambaram Taluk of Kancheepuram District. The Tambaram – Mudichur – Sriperumbudur Road Km 0/0 – 7/5 is under the

control of Chennai City Roads Division of Tambaram Sub Division. The Total Length of this Road is 7.500 Kms. This Road is classified as State Highways Roads (SH 110)

- ii. The Grand Southern Trunk road, Tambaram Mudichur Sriperumbuthur Road and Marmalong Bridge Irumbuliyur Roads are in Chennai Sub urban area. These are all important Road connected with Tambram ROB. Many Educational institutions, Hospitals, Tambaram Railway station, Tambaram Bus terminus and Tambram Market are located in this road and fasten developing Sub Urban area.
- iii. There is a Two-way Limited use Underpass existing across Railway Track (2 x 3.80 x 2.60m) to connect East Tambaram with the GST Road. Road users from East Tambaram uses the Limited Use Underpass, to cross the GST road to reach Mudichur and Tambaram Markets.
- iv. This limited use underpass shall be extended across GST road in such a way that underpass has to fall in between piers of Tambaram ROB and connecting Limited use Underpass existing across the railway track with Tambaram Mudichur service road. Land acquisition has to be carried out in some private parties' land to connect service road of Mudichur with GST road.

3. The Chief Engineer (H), Construction and Maintenance has stated that the estimate for the work of "preparation of Detail Project Report for the construction of Subway at Km 26/6 of GST road for linking East Tambaram with Tambaram Mudichur road and formation of service road" works out to Rs.50.00 lakh. This estimate includes Land Acquisition for service road.

4.The Chief Engineer (H), Construction and Maintenance has also stated that the scope of DPR involves alignment plan and preparation of LPS for acquiring private land and for preparation of alternation proposed for defence land, identification of private land for defence, etc. The acquisition of private land is required to connect the service road of Mudichur with GST road. Hence, estimate for land acquisition can be prepared only after completion of preparation of Detailed Project Report for the above work.

5.The Chief Engineer (H), Construction and Maintenance has therefore requested the Government to accord Administrative Sanction for an amount of Rs.50.00 lakh "for the preparation of Detail Project Report for the construction of Subway at Km 26/6 of GST road for linking East Tambaram with Tambaram Mudichur road and formation of service road".

6. The Government after careful examination, accept the proposal of the Chief Engineer (H), Construction and Maintenance and accord Administrative Sanction for a sum of Rs.50,00,000/- (Rupees Fifty lakh only) "for the preparation of Detail Project Report for the construction of Subway at Km 26/6 of GST road for linking East Tambaram with Tambaram Mudichur road and formation of service road" and accord

financial sanction for a sum of Rs.20,00,000/- (Rupees Twenty lakh only) for the financial year 2021-2022. The balance amount will be released in the subsequent financial year based on the requirement.

7. The expenditure sanctioned in para-6 above shall be debited under the following head of account:-

"5054-Capital Outlay on Roads and Bridges – 80 General – 004 Research and Development – AA Investigation / Estimation of Project Work under Road and Bridges – 416 Major Works – 01.Major Works."

8. The Chief Engineer (H), Construction and Maintenance is hereby authorized to incur the expenditure sanctioned in para 6 above.

9. The expenditure sanctioned in Para 6 above shall constitute an item of "New Instrument Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund. The Chief Engineer (Construction and Maintenance), Highways Department is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. The Chief Engineer (Construction and Maintenance), Highways Department is also directed to send a draft explanatory notes for inclusion the above expenditure in the Supplementary Estimates 2021-2022 to Finance (BG-I/PW-I) Department without fail.

10. This order issues with concurrence of Finance Department vide its U.O.No.52526/PW-I/2021, dated: 07.12.2021 and Additional Sanction Ledger No.1098 (One thousand and ninety eight)
