3. In the letter third read above, the Project Director (FAC), Chennai-Kanyakumari Industrial Corridor Project has stated that in G.O.(Ms) No.120. Highways and Minor Ports (HS2) Department, dated 18.07.2018 and G.O.(Ms) No.145. Highways and Minor Ports (HS2) Department, dated 26.11.2019 the validity of sanction of posts has not been mentioned. But in the proposals of the Project Director, Chennai-Kanyakumari Industrial Corridor Project, referred to in the G.O.(Ms) No.120. Highways and Minor Ports (HS2) Department, dated 18.07.2018 it has been mentioned that the tentative salary component for Land Acquisition and Resettlement & Rehabilitation in Project Implementation Unit and Field Land Acquisition and Resettlement & Rehabilitation Unit is about Rs. 41 Crores for a period of 3 years. Citing the above mention, some of the Treasuries have raised audit in the salary bills for July '21 saying that the period of sanction of posts for 3 years have expired on 17.07.2021 and insisted on orders for further extension of post sanction. Since, there is budget allotment for salary and non-salary component for the financial year 2021-2022, the Project is able to manage to get the salary bills passed.

4. The Project Director (FAC), Chennai-Kanyakumari Industrial Corridor Project has further stated that considering the pending volume of Land Acquisition works, it is felt that the existence of Land Acquisition and Resettlement & Rehabilitation Unit at Headquarters and field Land Acquisition and Resettlement & Rehabilitation Units with the support staff sanctioned in the Government Orders is absolutely necessary till the closure of the Project and requested that necessary amendments to the following Government Orders, mentioning that the sanction of posts accorded is valid till the closure of CKIC Project or all the Land Acquisition works are completed whichever is earlier, as was done for Tamil Nadu Road Sector Project-II.
