



ABSTRACT

Highways Department – Announcement made by the Hon'ble Minister for Public Works, Highways and Minor Ports Department during the Budget Session 2022–2023 – “Construction of Road Over Bridge at km 0/2 of Sedapalayam – Vaikkalpalayam Town Panchayat road branching at km 2/6 of the road from Kamanaickanpalayam – Annur road to Vadukkankalipalayam at Railway km 457/9-11 in lieu of existing LC.No.137 in between Vanjipalayam and Somanur Railway Stations” – Administrative and Financial Sanction – Accorded – Orders – Issued.

ORDER:

In the Government order first read above, orders were issued according Administrative Sanction for preparation of Detailed Project Report for “Construction of Road Over Bridge at km 0/2 of Sedapalayam-Vaikkalpalayam Town Panchayat road branching at km 2/6 of the road from Kamanaickenpalayam-Annur road to Vadukkankalipalayam at Railway km 457/9-11 in lieu of existing Level Crossing No.137 in between Vanjipalayam and Somanur Railways Stations” for an amount of Rs.26.99 lakhs.

2. In the Government order second read above, orders were issued according Administrative Sanction for carrying out Land Acquisition for the work of “Construction of Road Over Bridge at km 0/2 of Sedapalayam-Vaikkalpalayam Town Panchayat road branching at km 2/6 of the road from Kamanaickenpalayam-Annur road to Vadukkankalipalayam at Railway km 457/9-11 in lieu of existing Level Crossing. No.137 in between Vanjipalayam and Somanur Railways Stations for an amount of Rs.14.75 Crore.

3. During the budget session 2022-2023, the Hon'ble Minister for Public Works, Highways and Minor Ports made the following announcement in the floor of the Assembly on 12.04.2022: (Budget Demand No:21)

4. The Chief Engineer (H), Projects in his letter third read above has submitted the proposal for the work of "Construction of Road Over Bridge at km 0/2 of Sedapalayam – Vaikkalpalayam Town Panchayat road branching at km 2/6 of the road from Kamanaickanpalayam– Annur road to Vadukankalipalayam at Railway km 457/9-11 in lieu of existing LC.No.137 in between Vanjipalayam and Somanur Railway Stations". The details of the above proposal are given below:-

- i. The Road Over Bridge alignment starts at chainage 0.000m (i.e) km 2/700 of the road branching from Kamanaickenpalayam – Annur road to Vadukankalipalayam road and ends at Ch:673.681 (Village road which connects the Sedapalayam – Vaikkalpalayam Town Panchayat road with Railway culvert at km 2/015 of road branching from Kamanaickenpalayam – Annurroad to Vadukankalipalayam road). The vehicular traffic on this road is very heavy.
- ii. The proposed Road Over Bridge benefits Sedarpalayam, Vaikalpalayam, Vadukankalipalayam, Semandapalayam, Somanur etc., The TVU at this LC is 1,23,000 during proposal stage. The Railway gate is closed many times each day for train movements. This causes much inconvenience to road users and also to the local public. Hence, it is very essential to construct ROB in lieu of this level crossing to provide uninterrupted train and vehicle movement.

5. The Chief Engineer (H), Projects has therefore requested the orders of Government to accord Administrative Sanction for the work of "Construction of Road Over Bridge at km 0/2 of Sedapalayam – Vaikkalpalayam Town Panchayat road branching at km 2/6 of the road from Kamanaickanpalayam – Annur road to Vadukankalipalayam at Railway km 457/9-11 in lieu of existing Level Crossing No.137 in between Vanjipalayam and Somanur Railway Stations" for an amount of Rs.24,52,00,000/-.

6. The Government after careful examination, accept the proposal of the Chief Engineer (H), Projects and accord Administrative Sanction for "Construction of Road Over Bridge at km 0/2 of Sedapalayam – Vaikkalpalayam Town Panchayat road branching at km 2/6 of the road from Kamanaickanpalayam – Annur road to Vadukankalipalayam at Railway km 457/9-11 in lieu of existing Level Crossing No.137 in between Vanjipalayam and Somanur Railway Stations" for an amount of Rs.21,53,88,012/- (Rupees Twenty One Crore Fifty Three Lakh Eighty Eight Thousand and Twelve only) and accord financial sanction for a sum of Rs.75,00,000/- (Rupees Seventy Five Lakh Only) in the current financial year 2022-2023. The balance amount will be released in the subsequent financial years, based on the requirement.

7. The expenditure sanctioned in para 6 above shall be debited to the following head of account:-

5054 - Capital Outlay on Roads and Bridges – 03 – State Highways –
101 - Bridges - State's Expenditure – JG – Construction of over and under bridges in lieu of existing level crossings – 416 - Major Works –
01 – Major Works.

8. The expenditure sanctioned in Para-6 above is an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Chief Engineer (Projects), Highways Department is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. He is also directed to send a draft explanatory notes for including the above expenditure in the Supplementary Estimates 2022-2023 to Finance (BG-I/PW-I) Department without fail.
