Highways Department – Projects wing – Coimbatore Circle – Coimbatore Division – Railway Work Programme 2016-17 - Construction of Road Over Bridge at km 3/2 of the road branching from km 133/8 of Salem - Cochin road to Karavazhi Madhappur (via) Kaniyur in lieu of existing Level Crossing No. 141 at Railway km 463/23-25 in between Somanur and Sulur Railway stations – Administrative and Financial Sanction - Accorded – Orders – Issued.

ORDER:-

During the budget Demand the Hon'ble Minister for Public Works, Highways and Minor Ports has announced the following.

"இரயில்வே மேம்பாலங்கள் எட்டு மாவட்டங்களில் 12 இடங்களில் ரூ.577.27 கோடி மதிப்பீட்டில் கட்டப்படும்."

- 2. In the Government Order first read above among others the Government accorded Administrative Sanction for an amount of Rs.25.51 lakh for the preparation of Detailed Project Report for the construction of Road Over Bridge at km 3/2 of road branching from km 133/8 of Salem Cochin road to Karavazhi Madhappur (via) Kaniyur in lieu of existing Level Crossing No.141 at Railway Km 463/23-25 in between Somanur and Sulur Railway station.
- 3. In the Government order 2nd read above, among others, the Government accorded Administrative Sanction for an amount of Rs.5.00 crore for carrying out Land Acquisition for the above work.
- 4. In the letter third read above, the Chief Engineer (Projects) Highways Department, has stated that the above Road Over Bridge work has been approved

by the alignment committee and the approved Railway General Arrangement Drawing for this work was received from the Southern Railways. Based on the approved alignment and field particulars, the Specification report along with Detailed Quantity Estimate and Structural Drawings for Road Over Bridge has been formulated and communicated by the Chief Engineer (H), Planning, Designs & Investigation. The technical details and the cost estimate for the above work have been prepared for an amount of Rs.23,95,60,000/- adopting the Current Schedule of Rates 2021-2022. The Road Over Bridge alignment starts at chainage 0.000m (i.e) km 2/780 of the road branching at Km 133/8 of Salem - Cochin to Karavazhi Madhappur (via) Kaniyur (ODR) and ends at chain age 756.44m at km 15/370 of Chinniyampalayam - Somanur road (MDR). The vehicular traffic on this road is very heavy. This proposed Road Over Bridge construction benefits Karavazhi, Madhapur, Sulur, Somanur, Kaniyur etc. The Railway gate is closed very often for train movements. This causes much inconvenience to road users and also to the local public. Hence, it is very essential to construct Road Over Bridge in lieu of this level crossing to provide uninterrupted train and vehicle movement.

- 5. The Chief Engineer (Projects), Highways Department, has therefore requested the Government to accord Administrative sanction for a sum of Rs.23,95,60,000/- for the work of "Construction of Road Over Bridge at km 3/2 of the road branching from km 133/8 of Salem Cochin road to Karavazhi Madhappur (via) Kaniyur in lieu of existing LC. No. 141 at Railway km 463/23-25 in between Somanur and Sulur Railway stations" under Railway Works Programme 2016-2017 on cost sharing basis.
- 6. The Government after careful examination, accept the above proposal of the Chief Engineer (Projects), Highways Department and to accord Administrative sanction for a sum of Rs.19,52,83,876/- (Rupees Nineteen Crore Fifty Two Lakh Eighty Three Thousand Eight Hundred and Seventy Six only) (as in Annexure) for the work of "Construction of Road Over Bridge at km 3/2 of the road branching from km 133/8 of Salem Cochin road to Karavazhi Madhappur (via) Kaniyur in lieu of existing LC. No. 141 at Railway km 463/23-25 in between Somanur and Sulur Railway stations" under Railway Works Programme 2016- 17 on cost sharing basis and accord financial sanction for a sum of Rs.50,00,000/- (Rupees Fifty Lakh Only) in the current financial year 2022-2023. The balance amount will be released in the subsequent financial years based on the requirement.
- 7. The expenditure sanctioned in para-6 above shall be debited to the following head of account.

"5054 - Capital outlay on Roads and Bridges - 03. State Highways - 101. Bridges - State's Expenditure - JG. Construction of Over and Under bridges in lieu of existing level crossings - 416. Major works - 01. Major works."

8. The Chief Engineer (Projects), Highways Department, is authorized to draw and disburse the amount sanctioned in para 6 above.

- 9. The expenditure sanctioned in Para 6 above is an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by drawl of an advance from the Contingency Fund. The Chief Engineer (Projects), Highways Department is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. He is also directed to send a draft explanatory notes for including the above expenditure in the Supplementary Estimates 2022-2023 to Finance (B.G-I / PW-I) Department without fail.
- 10. This order issues with the concurrence of the Finance Department vide its U.O.No.35374/PW-I, dated 16.07.2022 and Additional Sanction Ledger No.0736 (Seven Hundred and Thirty Six only)
