ORDER:

The Hon'ble Chief Minister of Tamil Nadu has made the following announcement in the floor of Assembly during the Budget Session on 15.07.2019 as follows:-

- "17 மாவட்டங்களில் உள்ள 379 கிராமங்களில் வசிக்கும் 9,59,356 மக்கள் பயனடையும் வகையில், ரூ.155.80 கோடி மதிப்பீட்டில் அரசு மற்றும் ஊராட்சி ஒன்றிய சாலைகளில் 42 ஆற்றுப் பாலங்கள் கட்டப்படும்"
- 2) Based on the above, the Chief Engineer, NABARD and Rural Roads, Highways Department has sent the proposal for the "Construction / Reconstruction of 42 bridges at a cost of Rs.155.80 crore for the financial year 2019-2020" and stated that on construction of these bridges across Rivers/Streams/Odai etc. it will reduce the travelling distances to reach the nearby villages in the other side of the River / Stream / Odai etc. in all seasons without any hindrances. Similarly, on completion, these bridges serve the general public such as school going children, farmers, business people etc., by way of reducing travelling distances and ensure connectivity in all weather conditions and reduce the vehicle operating cost. The estimates prepared in the above proposal are based on the current Schedule of Rates i.e., 2019-2020 and the provisions made in the estimate are as warranted by the site condition.
- 3) After detailed examination, the Government have restricted the above proposal as to "Construction / Reconstruction of 27 Bridges at a cost of Rs.100.00 Crore

and forwarded the same to NABARD Bank under NABARD loan assistance scheme for the year 2020-2021" on 27.06.2020.

- 4) Accordingly, the Chief Engineer, NABARD and Rural Roads, Highways Department has furnished the proposal for 26 bridge works [except one work in Dindigul District which was already taken up by Construction and Maintenance Wing] at a cost of Rs.9821.35 Lakh for approval of the Government.
- 5) In the letter second read above, the Deputy General Manager, NABARD has informed that the 190th Project Sanction Committee (PSC) held on 21st August 2020 given Concurrence for the 26 Bridge works at a cost Rs.9,703.32 Lakh in which Rs.7,762.65 Lakh as RIDF-XXVI of NABARD Loan Assistance for the year 2020-2021 and Rs.1,940.67 Lakh as State Share under 80:20 ratio.
- 6) In the letter third read above, the Chief Engineer, NABARD and Rural Roads, Highways Department has therefore requested the Government to accord Administrative Sanction for Rs.9,703.32 Lakh for the Construction / Reconstruction of 26 Bridges under NABARD Loan Assistance RIDF-XXVI for the year 2020-2021.
- 7) The Government after careful examination, accept the proposal of the Chief Engineer, NABARD and Rural Roads, Highways Department and hereby accord Administrative Sanction for the Construction/Reconstruction of 26 Bridges as detailed in Annexure to this order at a cost of Rs.9,703.32 Lakh (Rupees Ninety Seven Crore Three Lakh and Thirty Two Thousand only), in which Rs.7,762.65 lakh as RIDF-XXVI of NABARD Loan Assistance for the year 2020-2021 and Rs.1,940.67 lakh as State Share under 80:20 ratio. Necessary funds will be released in the next financial year and subsequent financial year based on the requirements.
- 8) The expenditure sanctioned in para 7 above shall be debited to the following Head of Account:-

"5054 Capital Outlay on Roads and Bridges – 04 District and Other Roads - 337 Road works – State's Expenditure – JZ Construction / Reconstruction of Bridges with Loan Assistance from NABARD – 416 Major Works-01.Major Works".

9) The expenditure sanctioned in Para 7 above shall constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. The Chief Engineer (NABARD and Rural Roads), Highways Department is directed to send necessary draft explanatory notes for the inclusion of the above expenditure in the supplementary estimates for the year 2020-2021 to Finance (B.G-I / PWD-I) Department at the appropriate time without fail. The Chief Engineer (NABARD and Rural Roads), Highways Department is authorized to incur the above expenditure only after obtaining approval from the Legislature.

10) This order issues with the concurrence of Finance Department vide its U.O.No.39396, dated 02.11.2020 and ASL No.805 (Eight Hundred and Five).
