## ORDER:

In Government Order fourth read above, Administrative Sanction was accorded for the engagement of consultants for preparation of Detailed Project Reports for the Construction of 16 works (River Bridges 13 Nos), two bypass (New Road formation) one grade separator and preliminary works for eight works (Four Road Over Bridge Three bypass / New road formation and one Limited (Four Road Over Bridge Three bypass / New road formation and one Limited (Use Subway) including the Level Crossings No.427 and 449. Regarding Road Use Subway) including the Level Crossings No.427 and 449. Regarding Road Over Bridge at LC.No.83 in Pavoorchatraam, the work will be taken up under Over Bridge at LC.No.83 in Pavoorchatraam, the Work will be taken up under Tamil Nadu Road Sector Project -II scheme by the Tamil Nadu Road Sector Project wing on Public Private Partnership basis.
    - 6. During Collectors' Conference 2012-13, the Hon'ble Chief Minister has announced the Construction of Railway Over Bridge at km 23/6 of Srivilliputhur Sivakasi Virudhunagar Aruppukottai Thiruchuli Narikudi Parthibanur road (SH-42) in lieu of existing Level Crossing No.424 between Virudhunagar road (SH-42) in lieu of existing Level Crossing No.424 between Sivakasi and Sivakasi Railway Stations at Railway km 559/700-800 in between Sivakasi and Thiruthangal Railways stations in Virudhunagar District and "In-principle" and Thiruthangal Railways stations in Virudhunagar District and has been approval was accorded in Government Order fifth read above, and has been included in the above 12 works.

7. The Chief Engineer (Projects), Highways Department has therefore, requested orders of Government to accord Administrative Sanction for Rs.351.23 lakh for the preparation of Detailed Project Reports for the following 12 works:-

- 8. The Government after careful consideration, accept the proposal of the Chief Engineer (Projects) Highways Department and accord Administrative Sanction for an amount of Rs.351.23 Lakhs (Rupees Three crore Fifty One lakhs and Twenty Three thousand only) for the work of Preparation of Detailed Project Reports for the Construction of 12 Road Over Bridge/Road Under Bridge (mentioned in para 7 above) in lieu of existing Level Crossings under Railway Works Programme 2015-2016 on cost sharing basis with Southern Railways.
  - 9. The expenditure sanctioned in para-8 above shall be debited to the following Head of Account:-

5054 - Capital Outlay on Roads and Bridges - 80 - General - 004 -Research and Development - I - Non-Plan -AA-Investigation / Estimation of project work under Roads and Bridges - 16 Major Works.

10. The expenditure sanctioned in para 8 above is an item of "New Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Construction and Maintenance), Highways Department, Chennai is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. He is also requested to send a draft explanatory notes for including the above expenditure in the Supplementary Estimates 2015-16 to Finance (PW.I) Department without fail.
