ORDER:-

In the Government Order first read above, Administrative Sanction was accorded to carry out Land Acquisition for an amount of Rs.178.00 Lakh for the work of "Construction of Road Over Bridge at km 3/0 of Goodanagaram – Anakannallur road in lieu of existing Level Crossing No.67 at Railway km 160/2-4 in between Melalathur and Valathur Railway stations".

2. The Committee on Revised Administrative Sanction in its meeting held on 01.12.2020 has recommended the following proposal of the Chief Engineer (Projects), Highways Department.

- 3. In the letter second read above, the Chief Engineer (Projects), Highways Department has requested the Government to accord Revised Administrative Sanction for carrying out Land Acquisition for the work of "Construction of Road Over Bridge at km 3/0 of Goodanagaram Anakannallur road in lieu of existing Level Crossing No.67 at Railway km 160/2-4 in between Melalathur and Valathur Railway stations" for an amount of Rs.4,92,00,000/- as recommended by the Revised Administrative Sanction committee.
- 4. The Government after careful examination of the proposal of the Chief Engineer (Projects), Highways Department accord Revised Administrative Sanction for an amount of Rs.4,39,26,064/- (Rupees Four crore thirty nine lakh twenty six thousand and sixty four only) for carrying out Land Acquisition for the work of "Construction of Road Over Bridge at km 3/0 of Goodanagaram Anakannallur road in lieu of existing Level Crossing No.67 at Railway km 160/2-4 in between Melalathur and Valathur Railway stations", as against the Administrative Sanction amount of Rs.1,78,00,000/- and accord Financial Sanction for a sum of Rs.2,61,26,064/- (Rupees Two crore sixty one lakh twenty six thousand and sixty four only)
- 5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:-

"5054 – Capital Outlay on Roads and Bridges – 03. State Highways – 101. Bridges – State's Expenditure – JG. Construction of over and under bridges in lieu of Existing Level Crossings – 464. Lands – 01.Lands"

- 6. The Chief Engineer (Projects), Highways Department is authorized to incur the expenditure sanctioned in para 4 above.
- 7. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund. The Chief Engineer (Projects), Highways Department is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to

Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. The Chief Engineer (Projects), Highways Department is also directed to send a draft explanatory notes for inclusion the above expenditure in the Supplementary Estimates 2021-2022 to Finance (BG-I / PW-I) Department at an appropriate time without fail.
