



ABSTRACT

Highways Department – Announcement made by the Hon'ble Minister for Public Works, Highways and Minor Ports Department during the Budget Session 2022-2023 – “Construction of High Level Bridge in lieu of existing old narrow bridge across Lower Bhavani Canal at km 12/4 of Pillaiyarkoilthurai – E.Chettipalayam road” – Administrative Sanction – Accorded – Orders – Issued.

ORDER:

In the Government order first read above, orders were issued according Administrative Sanction for Detailed Project Report for the work of “Construction of High Level Bridge in lieu of existing old narrow bridge across Lower Bhavani Canal at km 12/4 of Pillaiyarkoilthurai – E.Chettipalayam road” for an amount of Rs.3.75 Lakh.

2. During the budget session 2022-2023, the Hon'ble Minister for Public Works, Highways and Minor Ports made the following announcement in the floor of the Assembly on 12.04.2022: (Budget Demand No:21)

ஈரோடு, கரூர் மற்றும் திருச்சி மாவட்டங்களில் மொத்தம் 9 ஆற்றுப் பாலங்கள் ரூ.136.32 கோடி மதிப்பீட்டில் கட்டப்படும்.

ஈரோடு மாவட்டம், நடுப்பாளையம், வண்டிப்பாளையம், தொட்டிப்பாளையம், கூடக்கரை, ஈ.செட்டிப்பாளையம், மூனாம்பள்ளி, சுட்டிக்கல்மேடு மற்றும் ஆயிப்பாளையம் ஆகிய இடங்களில் கீழ்வாணி கால்வாயின் குறுக்கே ஏற்கனவே உள்ள பழைய குறுகிய பாலங்களுக்குப் பதிலாக 8 உயர்மட்டப் பாலங்களும், கரூர் மாவட்டம் நெருரையும், திருச்சி மாவட்டம் உன்னியூரையும் இணைக்கும் வகையில் காவேரி ஆற்றின் குறுக்கே உயர்மட்டப் பாலம் ஆகிய 9 உயர்மட்டப் பாலங்கள் ரூ.136.32 கோடி மதிப்பீட்டில் கட்டப்படும்.

3. The Chief Engineer (H), Projects in his letter second read above has submitted the proposal of “Construction of High Level Bridge in lieu of existing old

narrow bridge across Lower Bhavani Canal at km 12/4 of Pillaiyarkoilthurai – E.Chettipalayam road”. The details of the above proposal are given below:-

- i. The proposed Bridge site is located across the Lower Bhavani Canal at km 12/4 of “Pillaiyarkoilthurai - E.Chettipalayam road (ODR)” having traffic 4116 PCU. It is located in Nambiyur panchayat union, E.Chettipalayam village, in Erode district.
- ii. Due to construction of this High Level bridge around 2.20 lakh population from Nambiyur, Kosanam, Moonampalli, Gobichettipalayam, E.Chettipalayam, Ayalur, Kavilipalayam, Pulliyampatti, Ellathur, Irungalur, Kurumandur, Kondayampalayam, Koodakarai, Ukkaram, Arasur, Kadathur and other small hamlet villages will be benefited.
- iii. The existing bridge is 60 years old weak narrow arch bridge. The bridge width does not cater the increasing vehicle growth and causes frequent accidents due to non-standard width. Since the existing sub structure RR masonry is damaged at several sections and the surface is coated with cement mortar temporarily, it becomes essential to reconstruct the old weakened LBP canal bridges.

4. The Chief Engineer (H), Projects has therefore requested the orders of the Government to accord Administrative Sanction for the work of “Construction of High Level Bridge in lieu of existing old narrow bridge across Lower Bhavani Canal at km 12/4 of Pillaiyarkoilthurai – E.Chettipalayam road” at a cost of Rs.5.761 Crore.

5. The Government after careful examination, accept the proposal of the Chief Engineer (H), Projects and accord Administrative Sanction for the work of “Construction of High Level Bridge in lieu of existing old narrow bridge across Lower Bhavani Canal at km 12/4 of Pillaiyarkoilthurai – E.Chettipalayam road” for the amount of Rs.5.09 Crore (Rupees Five Crore and Nine Lakhs only) under the CRIDP Bank of sanction for the year 2022 – 2023.

6. The expenditure sanctioned in para 5 above shall be accommodated in the Bank of Sanction of CRIDP 2022-2023 and shall be debited to the following head of account:-

5054 - Capital Outlay on Roads and Bridges – 04 - District and other Roads – 337 – Road Works - State’s Expenditure – JU - Comprehensive Road Infrastructure Development Programme (CRIDP) – Other District Roads – 416 - Major Works – 01 - Major Works.
