The Chief Engineer (Highways) Projects has therefore requested orders of the Government to accord Revised Administrative Sanction for the work of "Construction of Road Over Bridge at km 12/8 of Suramangalam -Omalur (via) Muthunaickenpatty Road (Major District Road-696) in lieu of existing Level Crossing No.7 at Railway km 6/200-300 in between Magnesite and Omalur Railway Stations" for an amount of Rs.23,28,00,000/- (Rupees Twenty Three Crore Twenty Eight Lakh only) as recommended by Revised Administrative Sanction Committee.
- 4. The Government after careful examination, accept the proposal of Chief Engineer (Highways) Projects as recommended by Revised Administrative Sanction Committee and hereby accord Revised Administrative Sanction for a sum of Rs.23,28,00,000/- (Rupees Twenty Three Crore and Twenty Eight Lakh only) for the work of "Construction of Road Over Bridge at km 12/8 of Suramangalam-Omalur (via) Muthunaickenpatty Road (Major District Road-696) in lieu of existing Level Crossing No.7 at Railway km 6/200-300 in between Magnesite and Omalur Railway Stations" as against the Administrative Sanction amount of Rs.15,94,46,814/-.
