### ORDER:-

During the Budget Demand for 2019-2020 for Highways Department held on 15.07.2019, the Hon'ble Chief Minister has made fifteen announcements for developing the Highways infrastructure and providing a better connectivity. Out of this, under announcement No.3 viz., "To construct 3 Road Over Bridge works in Madurai, Thiruvallur and Kancheepuram Districts, Detailed Project Report will be prepared for an amount of Rs.1.08 Crore" pertains to Projects wing.

2. In the letter read above, the Chief Engineer (Projects), Highways Department has furnished the proposal among others, for the announcement No.3 for the preparation of Detailed Project Report at a cost of Rs.107.87 Lakhs for 3 Road Over Bridge works included under Railway Works Programme 2019-2020 as detailed below.

carrying out the preparation of Detailed Project Report for the following 3 Road Over Bridge works included under Railway Works Programme 2019-2020.
