### **ORDER:-**

In the Government order first read above, orders were issued constituting a Committee consisting of representatives of Finance Department, Highways and Minor Ports Department, Director General and concerned Chief Engineers' of Highways Department for scrutiny and Review of the Revised Administrative Sanction proposals.

2. In the Government order second read above, Administrative Sanction was accorded for the work of "Construction of ROB at km 2/2 of Salem New Bypass Road in lieu of existing LC No.183 at Railway km 189/400-500 in between Salem Town and Salem East Railway Stations" for an amount of Rs.45.63 Crore. Technical Sanction for Rs.50.15 Crore has been accorded for this work.

3. The Committee on Revised Administrative Sanction in its meeting held on 19.08.2020 has approved the following proposal of Chief Engineer (Highways) Projects:

The Chief Engineer (Highways) Projects has therefore requested the Government to accord Revised Administrative Sanction for an amount of Rs.92,40,00,000.00 for the work of "Construction of ROB at km 2/2 of Salem New Bypass Road in lieu of existing LC No.183 at Railway km 189/400-500 in between Salem Town and Salem East Railway Stations" as recommended by Revised Administrative Sanction Committee.

5. The Government after careful examination, accept the proposal of the Chief Engineer (Highways) Projects as recommended by Revised Administrative Sanction Committee and accord Revised Administrative Sanction for the work of "Construction of ROB at km 2/2 of Salem New Bye pass Road in lieu of existing Level Crossing No.183 at Railway km 189/400-500 in between Salem Town and Salem east Railway Stations" for an amount of Rs.92,40,00,000.00 (Rupees Ninety Two Crore and Forty Lakh only) against the originally Administrative Sanction amount of Rs.45,63,00,000.00 and also accord financial sanction for a sum of Rs.45,32,75,000.00 (Rupees Forty Five Crore Thirty Two Lakhs and Seventy Five Thousand only) for the Financial year 2020-2021 and the balance amount will be released in the subsequent financial year based on need basis.

6. The expenditure sanctioned in para-5 above shall be debited to the following Head of account:-

"5054.Capital Outlay on Roads and Bridges – 80 General – 800.  
Other Expenditure – State's Expenditure – JJ. Construction of Over and under Bridges in lieu of Existing Level Crossings –416. Major Works-01. Major Works"

7. The expenditure sanctioned in para 5 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature will be obtained in due course. The Chief Engineer (Highways) Projects is directed to send necessary draft explanatory notes for the inclusion of the above expenditure in the Supplementary Estimates for the year 2020-2021 to Finance (BG-I/PW-I) Department at the appropriate time without fail. The Chief Engineer (Highways) Projects is authorized to incur the above expenditure only after obtaining approval from the Legislature.


