NOTIFICATION

The Governor of Tamil Nadu having been satisfied that the lands specified in the schedule below are required for Highways purpose to wit for upgrading Nanguneri – Bharatavaram – Ovari Road (SH 89) upto ECR junction Km 0/000 to Km 35/200 in **Appuvillai Village, Radhapuram Taluk, Tirunelveli District** and it having already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds controlled and managed by the Divisional Engineer (Highways), Tamil Nadu Road Sector Project–II, Tirunelveli after considering the cause shown by the owner or other person having interest in the said lands as the case may be do hereby publish the following notice under subsection (1) of Section 15 of the Tamil Nadu Highways Act 2001 (Tamil Nadu Act 34 of 2002).

NOTICE

Under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002), the Governor of Tamil Nadu hereby acquires the dry lands specified in the Schedule below and measuring to an extent of 213 Sq.mtrs in Appuvillai Village, Radhapuram Taluk in Tirunelveli District to the same, a little more or less needed for TNRSP-II Highways purpose, to wit for upgrading Nanguneri – Bharatavaram – Ovari Road (SH 89) upto ECR junction Km 0/000 to Km 35/200.
