Highways Department – NABARD and Rural Roads – Namakkal District - Change in Nomenclature of the work as “Land Acquisition for Forming By-pass to Namakkal Town Km. 0/0 – 22/387 including Link Road to a length of 200m branching at Km 0/8 of Namakkal By-pass to proposed Namakkal Bus stand” - Orders - Issued.

ORDER:-

In Government Order first read above, among others, Government accorded Administrative Sanction for Rs.1070.20 lakhs for the work of Land Acquisition for forming Namakkal By-pass.

2. In Government Order second read above, Government accorded Revised Administrative Sanction for Rs.2494.61 lakhs based on the demand raised by the District Revenue Officer, Namakkal due to increase in Guideline Value of lands.

3. In Government Order third read above, Government accorded in principle approval for the Construction of new Bus Stand to Namakkal Town.

4. In his letters fourth read above, the Chief Engineer (NABARD & Rural Roads), Highways Department has stated that a proposal for the Link road to a length of 200m connecting the By-pass at Km 0/8 and the proposed new Bus stand to Namakkal Town was sent to the District Collector, Namakkal and concurred by him, since no other suitable connectivity is available to the newly proposed bus stand location. As per the Approved Alignment, the total length of the Bypass is 22.660 km. Later, Revised Alignment was approved by the Alignment Approval Committee on 17.02.2014. As per

the Revised Alignment, the actual length of the proposed Bypass is 22.387 km. Due to revised alignment, change in Nomenclature of the work is required and it involves cost variation. In this regard, Revised Administrative Sanction proposal has been placed in the Revised Administrative Sanction committee held on 30.01.2019 and the proposal was accepted by the Revised Administrative Sanction committee.

5. In Government Order fifth read above, Government accorded IInd Revised Administrative Sanction for Land Acquisition for the work of "Forming By-pass to Namakkal Town Km 0/0-22/387 including Link Road to a length of 200m branching at Km 0/8 of Namakkal By-pass to the proposed Namakkal Bus stand" for an amount of Rs.87,00,00,000/- as recommended by the Revised Administrative Sanction Committee as against the 1st Revised Administrative Sanction for an amount of Rs.24,94,61,000/-.

6. The Chief Engineer (NABARD & Rural Roads), Highways Department has therefore requested for orders of the Government to Change the Nomenclature of the work as "Land Acquisition for Forming By-pass to Namakkal Town Km 0/0 – 22/387 including Link Road to a length of 200m branching at Km 0/8 of Namakkal By-pass to proposed Namakkal Bus stand" instead of "Land Acquisition for forming By-pass to Namakkal Town Km 0/0 – 22/660".

7. The Government after careful examination, accept the proposal of the Chief Engineer (NABARD and Rural Roads), Highways Department to Change the Nomenclature of the work as "Land Acquisition for Forming By-pass to Namakkal Town Km 0/0-22/387 including Link Road to a length of 200m branching at Km 0/8 of Namakkal By-pass to proposed Namakkal bus stand" instead of "Land Acquisition for forming By-pass to Namakkal Town Km 0/0-22/660".

8. This order issues with the concurrence of Finance Department vide its U.O.No.61804/PW- I/2019, dated 09.12.2019.
