ORDER :-

During Dr.M.G.R's Birth centenary celebration held at Thiruvarur on 19.08.2017 the Hon'ble Chief Minister announced the work of "Construction of High Level Bridge at Km 0/8 of Melapaalam – Iver Samathi road across Bamini river connecting Brindavan Nagar and Karthamathapuram in Mannarkudi town in Tiruvarur District".

2. The Chief Engineer (Projects) Highways who was requested to send a detailed report has since stated that the proposed High Level Bridge across Bamini river is located on ODR at Km 0/8 of Melapaalam – Iver Samathi road. The existing structure is damaged Foot Bridge. At present, there is no connectivity in the Bamini river between Brindavan nagar and Karthamathapuram in Mannargudi town which is very much inconvenient for the public. The people travelling to Mannargudi town and Mannargudi Railway station have to travel more than six kilometers to cross the river portion to reach their destinations and the details of cost requirement for the construction of High Level Bridge is as follows:

1 Preparation of DPR 8.00

2 Cost of bridge works 652.00

- 4. The Chief Engineer (Projects) Highways has therefore requested administrative sanction for preparation of DPR for the work of "Construction of High Level Bridge at Km 0/8 of Melapaalam Iver Samathi road across Bamini river connecting Brindavan Nagar and Karthamathapuram in Mannarkudi town in Tiruvarur District for an amount of Rs.8.00 lakhs.
- 5. The Government after careful examination accept the proposal of the Chief Engineer (Projects), Highways Department and accord administrative sanction for preparation of DPR for the work of "Construction of High Level Bridge at Km 0/8 of Melapaalam Iver Samathi road across Bamini river connecting Brindavan Nagar and Karthamathapuram in Mannarkudi town in Tiruvarur District for an amount of Rs.8.00 lakhs.
 - 6. The expenditure sanctioned in Para 4 above shall be debited under the following Head of Account:-

"5054-Capital Outlay on Roads and Bridges. -80-General-004-Research and Development-State's Expenditure-AA-Investigation/Estimation of project work under Roads and Bridges" – 16 Major works (D.P.Code 5054-80-004-AA 1609)

- 7. Necessary additional funds will be provided in the FMA 2017-18. Pending provision of funds in the FMA 2017-18, the Chief Engineer (C&M), Highways Department is authorised to draw and disburse the expenditure sanctioned in Para 5 above. The Chief Engineer (C&M) Highways is directed to include the above expenditure while sending the proposal for FMA 2017-18 to Government in Finance (PW1) Department without fail.
