NOTIFICATION

The Governor of Tamil Nadu having been satisfied that the lands specified in the schedule below have to be acquired for Highways purpose for the formation of By-pass Road to Tiruvannamalai Town starting from Cuddalore-Chittoor Road Km. 112/4 and ending at Km. 112/6 in connection with National Highways 66 in Tiruvannamalai District and it has already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds controlled or managed by the Divisional Engineer (NABARD and Rural Roads), Highways Department, Vellore District after considering the cause shown by the owner (or) other person having interest on such lands as the case may be hereby publish the following notice under Sub Section (1) of Section 15 of Tamil Nadu Highways Act 2001 (Tamil Nadu Act 34 of 2002).
