NOTIFICATION

The Governor of Tamil Nadu having satisfied that the lands specified in the Schedule below are acquired under TNRSP-II Highways purpose, to wit for upgrading Cuddalore – Chittoor Road (SH 09) at Km 41/700 to Km 44/000 & Km 45/000 to Km 66/190 and formation of a new link road between SH 09 & SH 137 (Km 66/190 to Km 71/147) in Aviyur Village, Thirukovilur Taluk, Villupuram District and it having already been decided that the entire amount of compensation to be awarded for the acquisition of lands is to be paid out of the funds controlled and managed by the Highways Department and after having considered the cause shown by the owner or other persons having interest in the said lands, as the case may be, do hereby issue and publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34/2002)

NOTICE

Under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002), the Governor of Tamil Nadu hereby acquires the dry lands specified in the Schedule below and measuring to an extent of 369 Sq.mtrs in Aviyur Village, Thirukovilur Taluk, Villupuram District to the same, a little more or less needed for TNRSP-II Highways purpose, to wit for upgrading Cuddalore – Chittoor Road (SH 09) at Km 41/700 to 44/000 & Km 45/000 to Km 66/190 and formation a new link road between SH09 & SH 137 (Km 66/190 to Km 71/147).

The plan of the lands under acquisition is kept in the Office of the Special District Revenue Officer (Land Acquisition), Tamil Nadu Road Sector Project-II, Chennai and the Special Tahsildar (Land Acquisition), Tamil Nadu Road Sector Project-II, Tiruvannamalai and may be inspected at any time during office hours.
