## ORDER:-

In the Government order first read above, orders were issued constituting a Committee consisting of representatives of Finance Department, Highways and Minor Ports Department, Director General and concerned Chief Engineers' of Highways Department for scrutiny and Review of the Revised Administrative Sanction proposals.

- 2. In the Government order second read above, orders have been issued according Administrative Sanction for the work of "Land Acquisition for Junction Improvement at Km 39/6 and km 42/4 of Omalur-Sankari-Thiruchengode-Paramathi Road (State Highways-86) and km 0/2 of Sankari-Mecheri Road (via) Edappadi (State Highways -220)" for an amount of Rs.80.00 Lakh under Comprehensive Road Infrastructure Development Programme 2017-2018.
- 3. The Committee on Revised Administrative Sanction in its meeting held on 19.08.2020 has approved the following proposal of Chief Engineer (Highways) Construction and Maintenance:

The Chief Engineer (Highways) Construction and Maintenance in the letter 3<sup>rd</sup> read above has therefore requested orders of the Government to accord Revised Administrative Sanction for the work of "Land Acquisition for Junction Improvement at Km 39/6 and km 42/4 of Omalur Sankari Thiruchengode Paramathi Road (SH-86) and km 0/2 of Sankari-Mecheri Road (via) Edappadi (SH-220)" for an amount of Rs.1,13,00,000/- as recommended by Revised Administrative Sanction Committee.
- 5. The Government after careful examination, accept the proposal of the Chief Engineer (Highways) Construction and Maintenance as recommended by Revised Administrative Sanction Committee and accord Revised Administrative Sanction for the work of "Land Acquisition for Junction Improvement at Km 39/6 and km 42/4 of Omalur Sankari Thiruchengode Paramathi Road (SH-86) and km 0/2 of Sankari-Mecheri Road (via) Edappadi (SH-220)" for an amount of Rs.1,13,00,000/-(Rupees One Crore and Thirteen Lakhs only) and accord financial sanction for a sum of Rs.33,00,000/- (Rupees Thirty Three Lakh only) in the financial year 2020-2021.
- 6. The expenditure sanctioned in para-5 above shall be met from the existing budget provision Budget Estimate 2020-2021 under the following Head of Account:-

State Highways - 337. Road Works-State's Expenditure-JI.
Comprehensive Road Infrastructure Development Progamme (CRIDP)
– State Highways-416. Major Works-01. Major Works".
