Announcement made by the Hon'ble Chief Minister during Dr. M.G.R. Birth Centenary celebration at Perambalur on 05.08.2017 – "Construction of High Level Bridge across Vellar River in between Km 1/0 of Thiruvalandurai Panchayat Union Road in Perambalur District and Km 1/0 of Keelakalpoondi Panchayat Union Road in Cuddalore District" - Administrative Sanction for preparation of DPR – Accorded – Orders – Issued.

ORDER :-

During Dr. M.G.R. Birth centenary celebration held at Perambalur on 05.08.2017, the Hon'ble Chief Minister has announced the work of "Construction of High Level Bridge across Kallar River in between Km 1/0 of Thiruvalandurai Panchayat Union Road in Perambalur District and Km 1/0 of Keelakalpoondi Panchayat Union Road in Cuddalore District"

2. The Chief Engineer (Projects) who was requested to send a detailed proposal relating to the above announcement has since stated that the river that separates the Thiruvalandurai (Perambalur District) and Keelakalpoondi is only Vellar river. But the Kallar river is in between Vannarampoondi village and V.Kalathur village. The proposed High Level Bridge is located in Panchayat Union road. Hence, the proposed work is to be renamed as "Construction of High level bridge across Vellar river in between Km 1/0 of Thiruvalandurai Panchayat Union road in Perambalur district and Km 1/0 of Keelakalpoondi Panchayat Union road in Cuddalore district.

3 The Chief Engineer (Projects) has stated that the Kallar river is a non-perennial river. During rainy season it has huge flood discharge from large catchment area. During flood, the public from the adjacent villages such as Keelakalpoondi, Vannarampoondi, V.Kalathur, Thiruvalandurai and Ayan Peraiyur cannot cross the river. Agricultural products could not reach their selling destinations in time which results in huge financial loss to the farmers. It is very difficult for the school children and also medical treatments for the villagers during rainy season. The details of cost requirement of High Level Bridge is as follows:

4. Hence, the Chief Engineer (Projects) Highways has requested to accord Administrative Sanction for preparation of DPR for the work of "Construction of High Level Bridge across Vellar River in between Km 1/0 of Thiruvandurai Panchayat Union Road in Perambalur District and Km 1/0 of Keelakalpoondi Panchayat Union Road in Cuddalore District" to carry out the DPR work for an amount of Rs.16.00 lakhs

5. The Government after careful examination accept the proposal of the Chief Engineer (Projects), Highways Department and accord Administrative Sanction for Rs.16.00 lakhs (Rupees Sixteen lakhs only) towards preparation of DPR for the work of "Construction of High Level Bridge across Vellar River in between Km 1/0 of Thiruvandurai Panchayat Union Road in Perambalur District and Km 1/0 of Keelakalpoondi Panchayat Union Road in Cuddalore District".

6. The expenditure sanctioned in para 5 above shall be debited to the following head of account .

7. Necessary funds will be provided in FMA 2017-18. Pending provision of funds in the FMA 2017-18, the Chief Engineer (C&M) Highways is authorized to draw and disburse the amount sanctioned in para 5 above. The Chief Engineer (C&M) is directed to include the above expenditure while sending the proposal for FMA 2017-18 to Government in Finance (PW-I) Department without fail.
