ORDER:-

In the Government Order first read above, orders were issued for fixation of the monthly Rent of Rs.24,000/- only towards occupying the Office of the Divisional Engineer (H), Tamil Nadu Road Sector Project II, Trichy and Office of the Special District Revenue Officer(LA) Trichy at Door No.14, Abdul Salam Street, Khaja Nagar,Trichy-620 020 owned by S.Habeeb Rahuman and M.Mohamed Sadhik for the period from 01.04.2014 and subsequently every year renewal of rent proceeding order were issued by the O/o. the Project Director, Tamil Nadu Road Sector Project –II, Chennai – 28 up to 31.03.2017.

2. In his letter third read above, the Additional Chief Secretary / Project Director (A/c), Tamil Nadu Road Sector Project –II has stated that, the Divisional Engineer(H) TNRSP-II, Trichy has reported that the above said office is still functioning in the above said building. Now the building owner has requested for enhancement of monthly rent from Rs.24,000/- to 27,500/- for the period from 01.04.2017 onwards. The necessary Reasonableness Rent Certificate from the Superintending Engineer (PWD) Buildings,Chepauk,Chennai-5 for Rs.27,500/- has been obtained.

The Additional Chief Secretary / Project Director (A/c), Tamil Nadu Road Sector Project –II has therefore requested the Government to sanction the enhanced monthly rent of Rs. 27,500/- for accommodating the Office of the Divisional Engineer (H) TNRSP-II, Trichy and Office of the District Revenue Officer(LA) Trichy at Door No.14, Abdul Salam Street, Kaja Nagar, Trichy 620 020 with effect from 01.04.2017.

4. The Government after careful examination, accept the proposal of the Additional Chief Secretary/Project Director (A/c), Tamil Nadu Road Sector Project-II and enhance the monthly rent of Rs. 27,500/- (Rupees twenty seven thousand and five hundred only) for accommodating the Office of the Divisional Engineer(H),

TNRSP-II, Trichy and Office of the District Revenue Officer (LA) Trichy at Door No.14, Abdul Salam Street, Kaja Nagar, Trichy 620 020 with effect from 01.04.2017.

5. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account:-
