## ORDER:

"During the Budget Session 2018-19, Hon'ble Chief Minister announced that detailed project report will be prepared for "widening and improvement of roads under the control of Highways Department including provision of drain cum foot path and improvement of junctions in Coimbatore, Thanjavur, Dindigul, Tuticorin and Madurai Corporation limits".

- 2) The Chief Engineer (Construction and Maintenance), Highways Department in her letter read above has stated that Coimbatore is the second largest city in Tamil Nadu and 16<sup>th</sup> largest urban agglomeration in India. The city is the second largest software producer in Tamil Nadu, next to Chennai. The software development is set to take an upswing with the launch of TIDEL Park and other planned IT parks around the city. Manufacturing, Research and Development Organisations like Tamil Nadu Agricultural University, South India Textile Research Association and other industries like PSG, Sakthi groups contribute a lot. Larsen and Toubro (L&T) has a 300-acre (1.2 sq km) campus on the outskirts of Coimbatore. Major automotive component industries, pump, wet grinder units function in this district. The City houses large number of small scale engineering companies. The Trade Fair complex, one of the country's largest, is owned by CODISSIA (Coimbatore District Small Industries Association).
- 3) The Chief Engineer (Construction and Maintenance), Highways Department has further stated that Coimbatore has several major bus stands. The town buses (intra-city) operate from the Town Bus Stand in Gandhipuram. Inter-city buses that connect Coimbatore operate from five different bus stands namely Gandhipuram Bus Stand (for buses going to East and North East to Erode, Tirupur, Salem and surrounding areas), Singanallur Bus Stand (for buses leading to Madurai, Trichy and the towns around them), Thiruvalluvar or SETC Bus Stand at Gandhipuram (for buses to Karnataka, Kerala and Chennai), Ukkadam Bus Stand (for buses to Palakkad, Palani, Dindigul and Kodaikanal and other nearby places) and Mettupalayam Road Bus stand (for buses going toward Mettupalayam and

Ooty). Apart from these, the Omni Bus Stand in Sathy Road, Gandhipuram caters to private bus operators. The city has a very high vehicle- population ratio. Coimbatore is connected through major NH network namely NH-544 (old NH-47-Salem-Coimbatore (via) Palakkad, Kochi), NH-81 (old NH-67 (Coimbatore – Karur – Tiruchirappalli – Jayamkondan -Chidambaram) and NH-181 (Coimbatore – Ooty – Gundalpet) and NH-948 (Coimbatore to Bangalore (via) Pollachi, Sathyamangalam, Chamrajnagar, Kollegal).

4) The Chief Engineer (Construction and Maintenance), Highways Department has stated that it is proposed to take up improvements like widening to four lane with centre median, drain, improving geometrics of intersections, junction improvements, reconstruction of culverts, road markings, furniture to facilitate unhindered traffic flow and improved road safety in the following roads.
