# ORDER:

During the Budget Speech the Hon'ble Deputy Chief Minister has made an announcement in the floor of Legislative Assembly on 14.02.2020 that "Strengthening and Maintenance works on State Highways and major District Roads "will be takenup under the" Performance Based Maintenance Contract (PBMC) Systems for 5 years in Gobichettipalayam (H), Construction and Maintenance Division for the year 2020-21.

- 2. In the letter 1<sup>st</sup> read above, the Chief Engineer (H), Construction and Maintenance was requested to send revised proposal by taking into consideration of Higher Provision of CD works, storm water drain, PCC retaining walls and to restrict the cost of CD works to 18% of the total cost.
- 3. In the letter 2<sup>nd</sup> read above, the Chief Engineer (H), Construction and Maintenance has sent the revised proposal to Government after considering and incorporating points raised by the Government and requested to accord Administrative Sanction for a sum of Rs.463 Crore for the Area Based Comprehensive Road Improvements, Strengthening and Maintenance Programme (AB-CRISM) I & II in Erode District, Gobichettipalayam Division as follows:-

The Government after careful examination accepted the proposal of the Chief Engineer (H), Construction and Maintenance and accord Administrative Sanction for a sum of Rs. 441,57,00,000/- (Rupees four Hundred and Forty One Crore Fifty Seven Lakh Only) for the Area Based - Comprehensive Road Improvements, Strengthening and Maintenance Programme (AB-CRISM) I & II in Erode District, Gobichettipalayam Division and accord financial sanction for a sum of Rs.5,00,00,000/- (Rupees Five Crore Only) in the current financial year 2020 – 2021 and the balance amount will be released in the subsequent financial year based on the requirements as follows:-

5. The expenditure sanctioned in para – 4 above shall be debited under the following Heads of accounts:-

"5054 - Capital Outlay on Roads and Bridges - 03 - State Highways - 337 - Road Works - State's Expenditure - JN - Comprehensive Road Infrastructure Development Programme (CRIDP) - Performance based maintenance contract "416 Major Works 01 - Major Works, IFHRMS (DPC:5054-03-337-JN-41601).

6. The expenditure sanctioned in Para – 4 above is an item of "New Instrument of Service" and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawn of an advance from the Contingency Fund. The Chief Engineer (Construction and Maintenance) Highways Department is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-1) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-1) Department. He is also directed to send a draft explanatory notes for including the above expenditure in the Supplementary Estimates 2020 – 2021 to Finance (BG-1/PW-I) Department at an appropriate time without fail.

- 7. The Chief Engineer (Construction and Maintenance) Highways Department is authorized to incur the expenditure sanctioned in para 4 above.
- 8. The Chief Engineer (H), Construction and Maintenance is directed to furnish the Terms of reference for approval of the Government within the appropriate time period.
- 9. This order issues with the concurrence of Finance Department vide its U.O. No.62/DS(SA)/PW-1/2020, dated:30.12.2020 and Additional Sanction Ledger No.1339 (One Thousand Three Hundred and Thirty Nine).
