**NOTIFICATION**

The Governor of Tamil Nadu having been satisfied that the lands specified in the Schedule below are acquired under TNRSP-II Highways purpose, to wit for strengthening and widening of Tirunelveli-Tenkasi Road (SH-39) from Km 47/000 to Km 50/600 in Gunaramanallur Village, Tenkasi Taluk in Tirunelveli District and it having already been decided that the entire amount of compensation to be awarded for the acquisition of lands is to be paid out of the funds controlled and managed by the Highways Department and after having considered the cause shown by the owner or other persons having interest in the said lands, as the case may be, do hereby issue and publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act, 34/2002)

**NOTICE**

Under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002), the Governor of Tamilnadu hereby acquires the dry lands specified in the Schedule below and measuring to an extent of 242 Square Metres in Gunaramanallur Village, Tenkasi Taluk in Tirunelveli District to the same, a little more or less needed for TNRSP-II Highways purpose, to wit for strengthening and widening of Tirunelveli-Tenkasi Road (SH-39) from Km 47/000 to Km 50/600.
