**NOTIFICATION**

The Governor of Tamil Nadu having been satisfied that the lands specified in the Schedule below are acquired under TNRSP-II Highways purpose, to wit for widening of Malliakarai - Rasipuram Road (SH 79) in **Mangalapuram Village, Rasipuram Taluk, Namakkal District** and it having already been decided that the entire amount of compensation to be awarded for the acquisition of lands is to be paid out of the funds controlled and managed by the Highways Department and after having considered the cause shown by the owner or other persons having interest in the said lands, as the case may be, do hereby issue and publish the following notice under sub-section (1) of section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act, 34/2002).
