From the Chairman and Managing Director, Poombuhar Shipping Corporation Limited Letter No.PSC/AM(A)/OAS/Retirement/2018, dated 21.06.2018 and 18.07.2018.

ORDER:-

The Principal Secretary / Chairman and Managing Director, Poombuhar Shipping Corporation Limited has stated that a proposal was submitted to the Board of Poombuhar Shipping Corporation Limited to consider and revise the retirement age limit from 58 years to 60 years for Office Assistants/Sweepers of Poombuhar Shipping Corporation Limited as followed for Government Employees in Rule 56(1) of Fundamental Rules. The Board of Poombuhar Shipping Corporation Limited vide its Resolution No.9 of the Minutes of the 313th Board Meeting held on 07.06.2018 passed the following resolution:-

“Every staff/Officer of the corporation EXCEPT Office Assistant/Sweeper shall retire when he/she attains the age of 58 years. The retirement age limit of Office Assistant/Sweeper of the Corporation is enhanced from 58 years to 60 years as per Fundamental Rules 56(1) of the Government of Tamil Nadu “.

“RESOLVED also that the above amendment to the Service Rules as per Fundamental Rules 56(1) of the Government of Tamil Nadu for enhancing the age limit from 58 years to 60 years for Office Assistant/ Sweeper of the Corporation shall be effective and will be implemented after approval by the Government of Tamil Nadu”.

2) The Principal Secretary/Chairman and Managing Director, Poombuhar Shipping Corporation Limited has requested orders of the Government to revise the retirement age limit from 58 years to 60 years for Office Assistants and Sweepers in Poombuhar Shipping Corporation Limited .

3) The Government, after careful consideration, accept the proposal of the Principal Secretary/Chairman and Managing Director, Poombuhar Shipping Corporation Limited and accordingly, revise the retirement age of Office Assistants

and Sweepers of Poompuhar Shipping Corporation Limited from 58 years to 60 years.

4) Necessary amendments to Service Rules of Poompuhar Shipping Corporation Limited will be issued separately.
