ORDER:

The Hon'ble Minister for Public Works, Buildings, Highways and Minor Ports has made the following announcements in the floor of the Assembly during the year 2022-2023 Budget Demand No.21:-

In the letter fourth read above, the Chief Engineer (Construction and Maintenance), Highways Department has sent a revised proposal for Comprehensive Road Infrastructure Development Programme 2022-2023 for an amount of Rs.5,581.80 crore in addition to the provision for works to the tune of Rs.718.20 crore for which Administrative Sanctions have already been accorded and requested for Bank of Sanction for Rs.6,300 crore. He has furnished the list of 2,263 works to be taken up under Comprehensive Road Infrastructure Development Programme 2022-2023 and requested to accord Administrative Sanction.

3. The Government, after careful examination of the proposal of the Chief Engineer (Construction and Maintenance), Highways Department, accord approval for a Bank of Sanction of Rs.6,300.00 crore (Rupees Six Thousand and Three Hundred Crore only) under Comprehensive Road Infrastructure Development Programme 2022-2023 and accord Administrative Sanction for 2,263 new works for a sum of Rs.5,581.80 crore (Rupees Five Thousand Five Hundred and Eighty One Crore and Eighty Lakh only) under Comprehensive Road Infrastructure Development Programme 2022-2023 as annexed to this order. The abstract of the new works taken up under Comprehensive Road Infrastructure Development Programme 2022-2023 is as follows:-

5. The Chief Engineer (Construction and Maintenance), Highways Department is permitted to initiate land acquisition process if necessary, even for works which do not specifically mention land acquisition in the nomenclature of works.

6. The Government accord in-principal approval for exemption from policy of allocation of 10% of Comprehensive Road Infrastructure Development Programme (CRIDP) fund towards urban improvement vide G.O.(Ms) No.102, Highways and Minor Ports (HF2) Department, dated 03.11.2021.

7. The Chief Engineer (Construction and Maintenance), Highways Department is permitted to change nomenclature of works, split / deletion / substitution of works if any (based on site condition), without any additional financial commitment. However, any change in nature of works sanctioned under this proposal shall be sent to Government for necessary orders.

8. The Chief Engineer (Construction and Maintenance), Highways Department is directed to prepare estimates as per Scheduled of Rates 2022-2023 and prevailing latest Goods and Services Tax Notification (of 18%). No Revised Administrative Sanction will be entertained due to the above increases for these works.

9. The Chief Engineer (Construction and Maintenance), Highways Department is directed to take up the works early and also to ensure that the works sanctioned herein are not included in any other schemes and have not been taken up previously.

10. This order issues with the concurrence of Finance Department vide its U.O. No. 146/DS (PT)/PW-1/2022, dated 29.09.2022.
